## Overview of our charity

We are the youth-led mental health charity working to integrate youth voice in mental health and wellbeing support. Our mission is to secure a brighter future for young people by creating a platform for them to shape the services they access.

Together, we champion meaningful change for a world where every young person feels valued and empowered to seek support when they need it. We want to help young people have a say in decisions that affect them. This is why our charity is youth-led at the core of decision making, with our trustees being aged 16-25.

Our values act as a guide for staff and Trustees about how we work at A Little Bit of Sunshine. Our 'ALBOS' values create a framework for taking actions and making decisions at every level of the charity.

## What we're working on

Providing support to young people looking for help with their mental

These workstreams are then translated into opportunities for our volunteers and the young people involved in our projects.

As a youth-led charity, we are committed to creating more opportunities for young people to develop into healthy and active citizens. We have identified a need to create roles that empower young people to take the lead, and we fully embrace our responsibility in making this a reality.

This is why we are committed to having young people lead the design and delivery of our projects from the beginning. Our newly formed Steering Group will lead the work across our workstreams to ensure they are fit for purpose and continuously assessed against a series of Key Performance Indicators (KPIs), objectives set by the board, stakeholders, and funders involved.

Much of the charity's work is educational and therefore qualifies us to be a registered charity. Legally, a charity must be run by a Board of Trustees whose duties are defined under charity law.

## Governance and the role of the Board

The A Little Bit of Sunshine Board is a group of dedicated young people aged 16-25 with diverse skills and experience from various sectors who volunteer their time to provide strategic guidance to the charity. The board of trustees is legally responsible for the charity.

The term 'governance' is not the same as delivery. Trustees do not have a role in campaigning or running projects. Instead, trustees oversee the effective management of the charity, ensuring compliance with its governing document and meeting its charitable objectives.

The board meets six times a year, in addition to other duties. The role of a trustee is a voluntary position that puts young people at the centre of what we do. Being a trustee is a significant commitment and can be challenging at times. However, the skills and experience gained in this role will open up further opportunities and showcase expertise in senior leadership, strategy, and governance.

A Little Bit of Sunshine appoints a team of volunteers, led by the Chief Executive, who is directly appointed by the Board. The CEO and their Executive Leadership Team are responsible for the day-to-day operational management of the charity.

## Our commitment to our Trustees

Once Trustees have been appointed to the Board, we will deliver an induction into the role of a Trustee and what the role entails. All trustees must attend this induction. The induction provides new trustees with information about A Little Bit of Sunshine, what we do and the role of a trustee. It will also help to refresh the knowledge of existing trustees and create an opportunity for the board and staff to work together to outline the charity's strategy and opportunities for growth.

## Trustee Role Description

## Summary

As a Trustee, your role will be to use your skills and personal experience to contribute to the work of the Board. The trustees are volunteers who form a collective body known as the Board of Trustees, sharing responsibility for all aspects of the governance of the organisation.

The purpose of the Board of Trustees is to advance the organisation, keeping within its charitable objectives. The trustee's role is focused on providing strategic oversight of the charity's operations and finances with day-to-day responsibilities in the hands of the CEO and executive leadership team.

## Time Commitment

You will be required to attend six full board meetings, and join at least one committee of the full board which meets in between the full board meetings. You will also have to read papers which will be circulated before board meetings or where necessary.

## Responsibilities

- To ensure that A Little Bit of Sunshine (ALBOS UK) complies with its governing document, charity law, company law and any other relevant legislation or regulations.
- To ensure ALBOS UK uses its resources exclusively in pursuance of its objectives: the charity must not spend money on activities which are not included in its own objects, no matter how worthwhile or charitable those activities are.
- To contribute actively to the board of trustees' role in giving firm strategic direction to ALBOS UK, setting overall policy, defining goals, and setting targets and evaluating performance against agreed targets.
- To act as Lead Trustee for a specific area of operation
- To attend and contribute to meetings of the Board and its Committees
- To safeguard the good name and values of ALBOS UK.
- To ensure the effective and efficient administration of ALBOS UK.
- To ensure the financial stability of ALBOS UK.
- To protect and manage the property of the charity and to ensure the proper investment of the charity's funds.
- To oversee the appointment of management staff and to their performance.

An offline version of the questions from the Trustee Application form can be accessed here.
We will then review all of the applications to determine if they meet the criteria outlined in the specification for the role of trustee. We will then invite a certain number of applicants to a virtual interview. Unfortunately, we cannot guarantee an interview to every applicant who completes the application form.

If you are shortlisted for an interview, you may be interviewed between the 8th and 12th of July 2024. It is important that you are available on one of those dates. The interview will assess in more detail how you meet the criteria for becoming a trustee.
