Thyroid UK is a charitable company working primarily within the United Kingdom. Formed in 1998, we became a company limited by guarantee in 2007 and in 2008 we became a registered charity: <a href="https://tinyurl.com/RegCharity">https://tinyurl.com/RegCharity</a>.

The provision of quality information for people with both diagnosed and undiagnosed thyroid disorders is the primary concern of Thyroid UK (our 'If you are undiagnosed' page is here: https://tinyurl.com/tukundiagnosed)

We work effectively in this field through dialogue with NHS departments and other medical institutions, networking with other voluntary organisations, and providing services direct to patients.

# **Our Objectives**

We use our objectives to focus on what people need and the work that we do. We ensure that this is discussed at every board meeting and incorporated in our Strategic Plan.

The relief of sickness of persons suffering from thyroid disease and related areas, for the benefit of the public, particularly but not exclusively by:

- a) providing information and support to people affected by thyroid disease and related conditions
- b) promoting public awareness in regard to thyroid disorders
- c) acting as a resource centre and disseminating information
- d) encouraging scientific research for the education, alleviation, care, treatment and cure of thyroid disease
- e) influencing public health policy for the benefit of people affected by thyroid disease

# Our Achievements in 2022-2023

We have worked with a fundraiser this year who has helped us gain funding to cover our core costs, the rent of the new office, an admin assistant and board and strategy meetings.

We have recruited four new trustees with specialist skills to help us govern Thyroid UK, campaign for better treatment and work with policy makers.

We have also worked with a new partner, The Wren Project, a listening service for individuals affected by autoimmune thyroid disease. People with thyroid disease often need to talk about their condition and how it affects them and The Wren Project is where we signpost people for this kind of support.

Also, we have started working with another new partner, Bequeathed, who make free wills for people, giving them the opportunity to donate to Thyroid UK.

We have used donations received from our lovely beneficiaries to work on our #T3Campaign and our new website.

Most of our achievements, however, is the work that we have done to support our beneficiaries:

# Providing information and support to people affected by thyroid disease #T3Campaign

We have campaigned further to ensure that patients can access liothyronine if they need to. We attended meetings with the Lord Hunt of Kings Heath OBE and the Lord Borwick as well as several meetings with other thyroid patient organisations over the past year.

In January, we worked with Lord Hunt on a Parliamentary Question:

"To ask His Majesty's Government, further to the Written Answer by Lord Markham on 15 December 2022 (HL4328), what assessment they have made of whether the NHS Devon Integrated Care Board has sufficiently taken account in its policies to support patients with hypothyroidism; and in particular, whether the Board has ensured that (1) national recommendations to not alter medication if a patient is stable on thyroid treatment are followed, (2) blanket reductions in the T3 dose to 10 µcg for all patients do not take place regardless of (a) individual needs, or (b) the recommendations of NICE, which gives 10µcg as a starting dose, rising up to 60µcg as necessary, and (3) regardless of whether patients can take levothyroxine or not, it is substituted it for (a) armour thyroid medicine, or (b) doses of T3 in excess of 10µcg. (HL4822)"

#### To which Lord Markham replied:

"No assessment has been made. Decisions about prescribing are made with the healthcare professional concerned, who has clinical responsibility for that particular aspect of a patient's care. Prescribers must ensure that the medicines considered appropriate for their patients can be safely prescribed and take account of the appropriate national guidance on clinical effectiveness and the local commissioning decisions of their respective integrated care boards (ICBs). NHS England formally oversees ICBs and has a legal duty to annually assess the performance of each ICB and publish their findings."

In July, Lyn Mynott had a meeting with Lord Hunt at the House of Lords followed by attending Oral Questions in Parliament:

"Lord Hunt of Kings Heath to ask Her Majesty's Government what steps they will take to prevent Clinical Commissioning Groups denying thyroid patients access to the drug liothyronine (T3) for the treatment of hypothyroidism."

A discussion then took place when concluded by Lord Kamall, Parliamentary Under Secretary of State for Innovation at the Department of Health and Social Care, stating:

"The noble Baroness raises a really important point about some of the blockages to patients getting T3. It is both the first and second-line advice from NHS England but also the NICE advice too. NICE always reminds us that it is independent, and that Ministers should not intervene, but we can call for meetings. NICE also recognises that a price change does change the equation. It has told me that it is open to new evidence with people able to consult and contact it about this."

In October, Lyn Mynott attended a Round table meeting with Lord Hunt, a leading endocrinologist and other thyroid representatives to discuss the way forward for thyroid patients needing liothyronine.

In July, we were informed that NHS England planned to publish a refreshed version as NHS England 'Liothyronine prescribing advice', alongside the 'Items which should not routinely be prescribed in primary care' and so a lot of work went into providing feedback to this including a meeting with NHS England Medicines Policy team.

People are very grateful to us for continuing to support them in this respect.

This work is still ongoing.

#### Membership

Our membership has remained fairly static at 1,000 members. They receive four magazines per year where they can read articles on various topics to help their thyroid health as well as thyroid news especially about our #T3Campaign. The membership fees we receive really help us to continue our work.

## **Telephone Helpline**

We have been working with our fundraiser on applications for grants so that we can run a telephone helpline, which our beneficiaries agreed would be helpful. We hope to receive some funding next year.

#### Website

We have spent a lot of time this year on placing content onto the new design and making sure that each page is correct. This takes some time and it was delayed due to work involved in planning our move to new premises. However, we are confident that the new website will launch in the near future.

#### **Information Pack**

As people still find the Information Pack very useful we have continued to publish this. A lot of people still prefer to be able to hold something in their hands and make notes rather than reading on a screen.

#### **Support Network**

We have continued to run our Support Network as people find that being able to meet others with the same condition really helps their physical and mental health.

### Our Online Community – HealtUnlocked.com

We have recruited a new admin for our community and she has helped a lot of people with their queries.

#### Social Media

Followers on our social media platforms, Facebook, Twitter, Instagram, LinkedIn and our online community, HealthUnlocked, have continued to grow. We post every day to keep our beneficiaries up-to-date. Any queries on the posts are responded to on a daily basis which often leads people to access further information either on our website or from their clinician.

## Other support

We receive many email queries and queries sent to us via our social media platforms every day. These requests for help can be very upsetting sometimes as people are so desperate for help and to feel better. We help them by sending various information relevant to their situation. They are always very grateful that we have been able to help them to take the next step in their thyroid journey:

### Promoting public awareness in regard to thyroid disorders

We have raised awareness of thyroid disease via our website, our online community, our social media pages, our e-news and our webinars. We also shared posts from various organisations including medical organisations, to our followers of their campaigns, that inform our beneficiaries about various aspects of thyroid disease.

The recordings of our webinars have been placed onto our YouTube channel for everyone to access.

This year, we held a webinar on World Thyroid Day where several speakers talked about a range of different topics.

### Acting as a resource centre and disseminating information

We have kept people informed of the latest thyroid issues, petitions, research, new guidance etc. on our social media platforms, our member magazine and our E-News which is sent to around 3,500 people who have registered for this.

The number of people asking for our information has increased and this shows us that our information is relevant and helpful to people.

We continue to update our research database with all the latest research into thyroid issues ready to be placed onto our new website so that patients and doctors can access research papers more easily.

# Encouraging scientific research for the education, alleviation, care, treatment and cure of thyroid disease

We have had further meetings with clinicians to discuss a research study on liothyronine, giving the patient view on the questions to be asked within the research protocol and we have helped several researchers this year by informing our beneficiaries how they can participate in thyroid research.

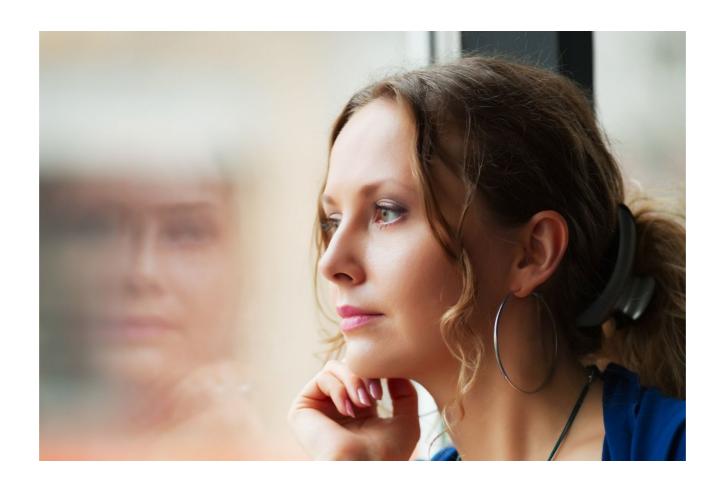
One of these pieces of research was for a Study by Professors at Aberdeen University Labour Market and Wellbeing Implications of Thyroid Disease, which showed that after waiting years to secure their diagnosis, more than 90% of adults still experience symptoms after receiving treatment. This needs to change.

We have also started working with a new partner, Leapcure, who work to achieve impactful medical breakthroughs for everyone. We invited our community members to share their patient stories, to help them make research more patient-centric.

We are now working with our fundraiser to raise funds for the James Lind Alliance Priority Setting Partnership which will enable patients, clinicians and researchers to work together to find the research questions that have not previously been asked about thyroid diagnosis and treatment.

# Influencing public health policy for the benefit of people affected by thyroid disease

We have had meetings with NHS England informing them about how thyroid patients are unhappy with the treatment they receive for their thyroid condition and have tried to encourage them to make changes to their guidance.

# Impact of our Work

Both hypothyroidism and hyperthyroidism affect 2% of women and 0.2% of men and 10% of the population have subclinical hypothyroidism and they are not treated for this which causes untold distress for many people.

We are contacted by hundreds of people each week via email, telephone, social media, our support network and our online community, who tell us their heart-breaking stories of how they are so ill even though they are on treatment. These people previously held down good jobs, had good family and social lives but are now unable to do their job properly or take part in social activities because they are too tired and suffer from many symptoms. These people need and receive our help.

## How we help

Thyroid UK gives people all the information they need about their condition and how to take control of their own thyroid health, how they can discuss their needs with their clinicians and how to go about gaining access to important tests and treatments.

Our information helps not only people in the UK but people from all over the world because information such as ours is lacking in other countries.

Thyroid UK often receives requests for help from the husbands, wives or children of people with thyroid disease. They are concerned that they are not getting the help they need and so come to us. We are able to answer their queries, send them the information they need and put their minds at rest.

We signpost people to the relevant thyroid guidance and suggest that they take this to their clinician for a full discussion.

#### **Free Prescriptions**

Newly diagnosed patients are not given the information they need e.g. patients with hypothyroidism are often not informed that they don't have to pay for prescriptions any more as their condition is a lifelong condition. Thyroid UK explains how to obtain free prescriptions.

#### Taking their medication

They are not told how to take their medication, especially that the medication should not be taken with food and various supplements and they are surprised when we inform them of this.

### **Have patience**

They are not told that improvement in their symptoms is not immediate and can take many months. This can cause low mood in people as they often cannot see the improvement they expect. We let them know that the road to wellbeing not only means taking their medication correctly but that they need patience as it can take some time to feel well again.

### Subclinical hypothyroidism

People with subclinical hypothyroidism are often sent away from their doctor's surgery having been told to come back in 3-6 months time for another test. They are not informed to make sure that they eat a healthy diet as the thyroid process needs all the vitamins, minerals and amino acids to work properly. We know that many people do not eat all the foods necessary for the thyroid to thrive. We help them understand this.

#### **Different brands**

In respect of hypothyroidism, not everyone does well on the standard treatment, levothyroxine. We inform them that a different brand, with different ingredients can make all the difference.

They are not aware that pharmacies have given them a different brand and don't understand what is happening when they start to get different symptoms. We inform them that they should always try to stay on the same brand if they can and if not, to check the ingredients of the brands if they start to get side effects.

## Liothyronine

Patients are not informed that there is a possibility that they do not convert levothyroxine into the active hormone, T3, sometimes caused by a particular gene. We inform our beneficiaries about this and that another hormone replacement treatment, liothyronine, can often make the difference between being very unwell and becoming as well as they were before they became ill with hypothyroidism.

Thyroid UK guides people through the process of finding out what their issue is so that they can become well again. People are often shocked that they were not informed about these aspects of their condition but very grateful to us that we have informed them and that our information helped them a lot.

Unfortunately, the latest guidance on liothyronine means that GPs need to refer all patients to a

specialist. However, since Covid, specialists are very behind with appointments and it can take over a year to get a specialist appointment now. We are finding that specialist appointments are being rejected and so the patient is left without any help.

If a patient does manage to see a specialist, it is up to the specialist to agree to prescribe liothyronine. Once agreed, there needs to be an agreement in place between the GP surgery and the specialist, and this is another barrier to getting the treatment that makes them well because not all surgeries are willing to agree to this, due to either the cost, or because they have been informed by their local commissioners that they cannot do this.

We inform people of exactly what they need to do to try to get access to this important thyroid hormone treatment. We have helped people regain their liothyronine when it has been withdrawn from them for no reason and helped some people get a trial of this medication.

"My doctor is positive about it, and he told me all it does is replace the missing hormone. I'm not too worried now, I feel confident that it's fine. Thank you for your emails. It's given me reassurance and clarification." Chaya

### Pharmacists and clinician's queries

Thyroid UK receives queries from pharmacists and clinicians about obtaining specialist thyroid hormones for their patients such as lactose free levothyroxine or mannitol free levothyroxine. We send them our Medications documents which includes lists of all ingredients of all UK thyroid medications.

People are always grateful for our support and let us know every day.



# Our Aims for 2023-24

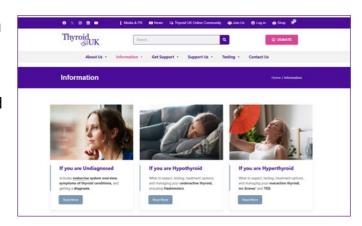
Our plans for this year are to continue to implement our new strategy to ensure that which includes:

#### **Campaign for Policy Change**

• Engage with policymakers, healthcare professionals, and patient communities to advocate for improved access to thyroid medications and treatments. The focus on this work in year one will be the continuation of the T3 campaign.

#### **Improve Information and Education**

- Create patient video resources
- Launch a new website with dedicated sections for T3 information
- Apply for and secure funding to implement a telephone helpline to provide accurate and accessible information to individuals affected by thyroid disease



• Set a target date for a conference to bring together beneficiaries, healthcare professionals, patients, and experts in thyroid disease management and treatment, and secure venue options

#### **Enhance Research and Collaboration**

Foster collaborative relationships with endocrinologists and other researchers to contribute to the evidence base for improved thyroid disease management. In particular this will mean:

- Supporting ongoing research when requested for example through helping to source volunteers to participate in studies, publicising ongoing work and providing comments on research
- Secure funding to enable TUK to begin the James Lind Alliance Priority Setting Partnership

#### Reach a Wider Audience:

- Continue to support the Wren Project listening service for individuals affected by autoimmune thyroid disease
- Where opportunities for joint work with other organisations become apparent, seek to support these initiatives through sign-posting or grant funding if available

- Seek professional assistance to develop and implement effective communication strategies that improve and expand Thyroid UK's reach and impact
- Prepare and conduct a survey to gather feedback from members and nonmembers. Analyse the survey findings to better understand needs and expectations and improve membership engagement and retention

#### **People Plan and CEO Succession:**

- Assess and update the CEO Succession Plan to accommodate the CEO's transition to part-time work in 2024.
- Review the existing People Plan to ensure that the correct issues on staffing, training, and development needs are identified and addressed within the organisation as it grows and evolves.

### **Keeping people informed**

We will continue to support beneficiaries by updating our Information pack with any new patient information leaflets; continue to run our Support Network and endeavour to recruit more support networkers; aim to recruit more admins for our online community in order that we can keep members updated with thyroid news and information; continue to send out requested information to members of the public in order to help them understand their condition and access the medication that helps them feel well and be able to live a normal work, social and family life; continue to update our research database in readiness for placing onto our new website so that patients and doctors can easily access any thyroid research papers.

#### Social Media

We will audit our social media work to improve the information we post thereby aiming to increase the number of followers on our social media platforms and encourage clinicians and policy makers in the UK to follow us.

#### **Webinars**

We aim to provide more webinars on various subjects that impact our beneficiaries. These will then be placed onto our new website and our YouTube channel.

# Influencing public health policy for the benefit of people affected by thyroid disease

We will continue to push for change in the way thyroid disease is diagnosed and treated by working with policy makers such as NHS England, the British Thyroid Association, local Integrated Care Boards and PrescQIPP.

# Structure, Governance and Management

#### **Board of Trustees**

The trustees for the purposes of Charity law and under the Company's Articles are known as members of the Board of Trustees. As the charity is also a Company Limited by Guarantee, the trustees are also directors of the company. The Board of Trustees meet four times a year to provide strategic direction and oversee current projects. They also meet once a year for a strategic planning meeting.

The Board consists of up to a maximum of ten members. An AGM is held annually. Trustees are elected at the AGM by the directors for a term of two years and are then eligible for re-election. A non-executive Chair, Deputy Chair and Treasurer are elected annually.

The Board exercises fiscal oversight, the appointment of the CEO and takes the lead on strategic risk management.

New trustees are recruited via professional trustee recruitment processes. We aim to recruit new trustees with diverse experience and perspectives to better help the charity achieve its aims. New trustees are given an Induction Pack, asked to sign a Code of Conduct form and complete a Declaration of Interest form.

The trustees confirm that they comply with the current statutory requirements of the charity's governing document and with GDPR. Our privacy policy is available on our website and we are registered with the Commissioner's Office. We are also registered with the Fundraising Regulator.

Most of the Thyroid UK trustees have some lived experience of having to deal with thyroid disease either directly or through family members which helps them understand how patients feel and which guides the strategic direction Thyroid UK should take.

#### **Staff**

The Board of Trustees delegates the day to day running of the charity to the Chief Executive Officer (CEO), Lyn Mynott. Lyn Mynott is the founder of Thyroid UK and is the driving force of the charity. She is passionate about changing the lives of people with thyroid disease who remain unwell and is determined to campaign for better thyroid health. The CEO works full time with some of her hours being voluntary.

The CEO is supported by her Personal Assistant (PA), Louise Hickey, a part time financial administrator/bookkeeper, Heidi Griggs and a part time administrative assistant, Carol Brown.

Our accountant examines the accounts for us on a voluntary basis, for which we are very grateful.

#### **Salaries**

The salary for the Chief Executive is reviewed and set regularly by the Board of Trustees.

Our approach to paying our staff is to pay them as fairly as we can given the limitations of our budget and to ensure we are fully compliant with all legislative requirements such as the National Minimum Wage.

The trustees do plan to set the salaries of all staff to be comparable with other charities of our size as soon as possible.

#### **Volunteers**

Thyroid UK is very lucky to have a large team of volunteers who help us to run Thyroid UK and support our beneficiaries.

Our support networkers hold groups where people can meet either in person or remotely, run a telephone helpline or can be contacted by email. Our Support Network list includes Thyroid UK support groups and independent thyroid support groups.

We have three medical advisers, one of whom is an endocrinologist, one of whom is a medical researcher and the other is a private naturopathic physician.

Our book review panel review relevant books for our magazine and we also have a volunteer who keeps our research database up to date.

Our Online Community is hosted on HealthUnlocked and monitored by our amazing admin team who work very hard monitoring the site and ensuring that members do not stray from our very strict guidance. They are also very adept at answering questions and dealing with any problems.

#### Going concern

The trustees have reviewed the charity's activities, financial position and risk management policies together with the factors likely to affect future development including the impact of Covid-19 related and cost of living related uncertainties in respect of voluntary donations and other income.

They have concluded that it is reasonable to expect the charity to have adequate resources to continue in operational existence for the foreseeable future.

Accordingly, the going concern basis of accounting continues to be adopted in preparing the financial statements.

#### **Public Benefit**

The trustees confirm that they have referred to the Charity Commission's general guidance on public benefit when reviewing our objectives and working on our strategy, work plans and future activities.

## **Risk Management**

Thyroid UK is committed to effective risk management. We have processes that ensure significant risks associated with the delivery and provision of our work and services are recognised, assessed, planned for and appropriately managed.

The Board of Trustees has ultimate responsibility for risk management of the charity. The Board delegates day-to-day responsibility for management of risks to the Chief Executive Officer (CEO). The CEO is responsible for the implementation of the risk management framework, monitoring of risks and controls, and reporting back to the Board on the effectiveness of controls. The CEO is also responsible for ensuring that significant crystallised risks and "near misses" including data breaches are escalated to the Board.

As part of the risk framework, the CEO is responsible for the maintenance of the Risk Policy and Risk Register. Material changes to the Risk Policy are approved by the Board. The Risk Register is reviewed at every board meeting.

Thyroid UK adheres to the Charity Commission's "Governance Code for Smaller Charities" and we regularly review our work to ensure we meet the code.

During 2022-23 the trustees were satisfied that risk management was undertaken in a satisfactory manner and responded to challenges which includes monitoring our income and expenditure on a monthly basis to ensure that we had sufficient funds in our reserves in case of closure due to the cost of living crisis.

# Statement of Trustees' Responsibilities

The trustees (who are also directors of Thyroid UK for the purposes of company law) are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice) including FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland.

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities Statement of Recommended Practice: Accounting and Reporting by Charities (2015)
- make judgements and estimates that are reasonable and prudent;
- state whether applicable UK Generally Accepted Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements: and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in business.

The trustees are responsible for keeping adequate accounting records that disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006.

They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In so far as the trustees are aware:

- there is no relevant independent examination information of which the charitable company's independent examiner is unaware; and
- the trustees have taken all steps that they ought to have taken to make themselves aware of any relevant independent examination information and to establish that the independent examiner is aware of that information.

The trustees are responsible for the maintenance and integrity of the corporate and financial information included on the charitable company's website.

Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

# Report of Independent Examiner Year ended 31st May 2023

I report on the accounts for the year ended 31st May 2023.

# Respective responsibilities of the Trustees and Independent Examiner

The charity's trustees consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

It is my responsibility to:

- examine the accounts under section 145 of the 2011 Act;
- follow the procedures laid down in the General Directions given by the Charity Commissioners section 145(5)(b) of the 2011 Act:
- and state whether particular matters have come to my attention.

#### **Basis of Independent Examiner's Statement**

My examination was carried out in accordance with the General Directions given by the Charity Commission.

An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records.

It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the management committee concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in a full audit, and consequently I do not express an audit opinion on the accounts.

#### **Independent Examiner's Statement**

In connection with my examination, no matters have come to my attention:

- (1) which give me reasonable cause to believe that in any material respect the requirements:
  - to keep accounting records in accordance with s.130 of the 2011 Act; or

I have independently examined the charitable company financial statements of Thyroid UK for the year ended 31 May 2023 which comprise the Statement of Financial Activities (incorporating an income and expenditure account), the Company balance sheet and the related notes.

## **Financial Review**

The financial results for the year are represented by the Statement of Financial Activities (incorporating an Income and Expenditure report).

#### **Overview**

We had an income in 2022/23 of £96,900.54 and an expenditure of £98,796.77, resulting in a deficit of £1,896.23. The deficit is primarily due to a decline in sponsorship and donations and an increase in support costs. However, our income was significantly bolstered by grants – the result of employing fundraising consultants during the year.

#### Income

Our overall income has increased by £2,456.36 this year.

We have seen a rise in our membership this year, which is reflected in an increase in membership income.

Test commissions have risen this year. We have seen a slight decrease in Other Commissions.

General donations have seen a decrease this year, possibly because of the cost of living crisis.

We have seen a decrease in our sponsorship income this year.

Our Gift Aid income has decreased this year as has our merchandise sales and information pack sales.

We received a grant of £10,000 from The National Lottery which was restricted funds. £5,000 was towards admin which enabled us to employ an extra administrator. £4,000 towards core costs which we have used to move into a suitable office space. £1,000 towards strategy and development which has gone towards our trustee meetings costs.

We received £2,000 from The Hospital Saturday Fund towards providing information and support to improve diagnosis and treatment for people with thyroid-related diseases and to empower them to take control of their own thyroid health.

We also received another grant of £750 towards Thyroid UK's work to help people suffering from thyroid disease and related conditions.

#### **Expenditure**

Our overall expenditure has increased by £3,081.25 this year and staff wages have increased again this year due to staff changes, but are still below the national average for comparable roles and we have an additional member of staff.

We have seen an increase in our Support Costs this year due to moving into the new office.

#### **Bank Accounts**

Thyroid UK has four bank accounts as follows:

Barclays Bank Account - for the day to day running of the organisation Barclays Bank Savings Account - for restricted and designated funds Petty Cash PayPal

All bank accounts are reconciled daily. A financial summary is provided at Board Meetings. The Barclays Bank Accounts are Community Accounts that offer free banking and support for small charities.

#### **Tangible Fixed Assets and Depreciation**

All tangible fixed assets costing more than £500 are capitalised and depreciated. Depreciation of fixed assets is calculated to write off the cost of each asset over the term of its estimated useful life (buildings 5 years, equipment 3 years). Assets are written off on a straight-line basis. All of our Fixed Assets are currently written off.

## **Subscriptions and Donations**

These are credited to the Statement of Financial Activities as received.

#### **Publication Sales**

Sales of books and publications are credited to the Statement of Financial Activities in respect of sales for the year.

## **Reserves Policy**

In accordance with our reserves policy, Thyroid UK aims to have reserves of three months of current running costs plus costs of closure.

The reserves are required for Thyroid UK to meet contractual liabilities should the organisation have to close. This includes redundancy pay, amounts due to creditors and commitments under leases; meeting unexpected costs that the charity may incur; replacing equipment as it wears out and ensuring that the charity can continue to provide a stable and quality service to those who need them.

Thyroid UK currently has sufficient reserves set aside as set out in the policy. In the event of reserves dipping below the target Thyroid UK will aim to restore the reserves to the minimum level within 12 months. This could be achieved by increased fundraising, increasing earned income or reducing expenditure.

If reserves exceed our target Thyroid UK will consider the likely expenditure over the next year and aim for reserves to return to our target level by the end of two years. This could be achieved in multiple ways aimed at improving the services that the charity provides to our beneficiaries.

The trustees consider current costs of closure and examine the level of reserves each year when setting the following years' budget. The reserves policy is reviewed every year.

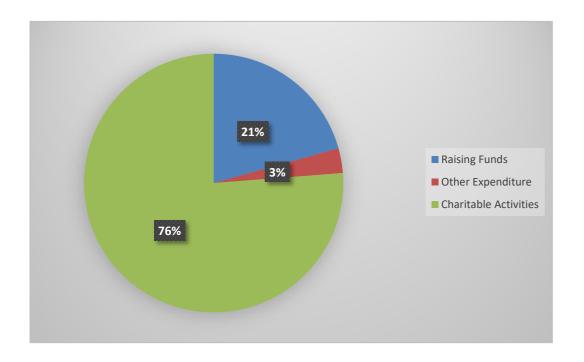
## **Related Party Transactions**

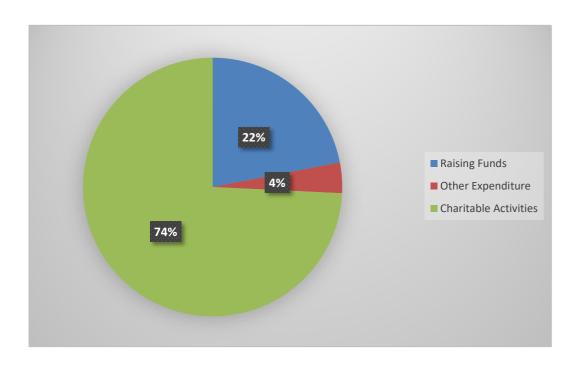

There were no trustee expenses paid in this financial year.

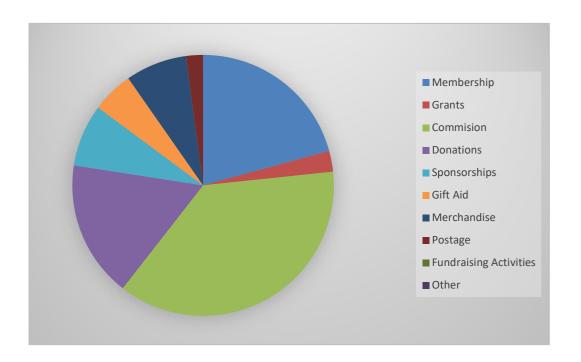
The charity maintains a liability insurance policy that includes indemnity cover for trustees at a cost to the charity of £450. The indemnity is limited to £100,000.

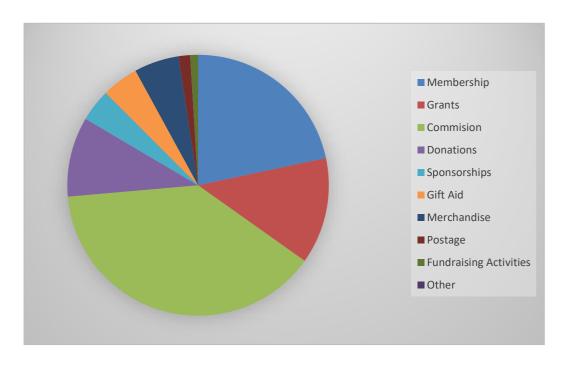
# **Statement of Financial Activity (SoFA)**



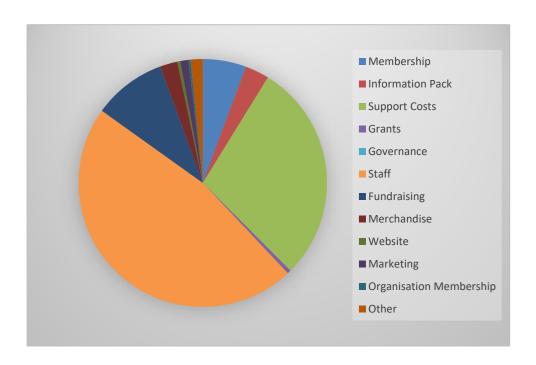


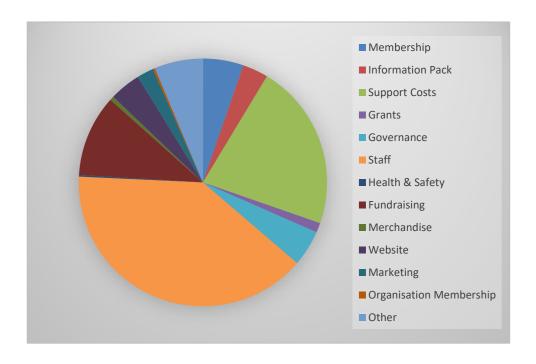
# **Where the Money Came From**
