Our perfect candidate will ideally have previous experience in fundraising and relationship management and will be confident in growing and managing a fundraising portfolio. We're looking for a great relationship builder, someone who is self-motivated and creative with excellent research, writing, presentational and organisational skills.

In this role, you'll work closely with our Senior Strategic Partnerships Manager and Senior Corporate Partnership Officers, to manage our portfolio of corporate partnerships, maximising income and benefits through the delivery of excellent partnership stewardship and a great supporter experience. You'll have your own portfolio of partnerships as well as new business pipeline, including Charity of the Year collaborations, event management and support, partnerships with pharmaceutical companies and sponsorship and Cause Related Marketing (CRM) opportunities.

You'll be instrumental in helping our team to reach our ambitious fundraising targets and ultimately improving the lives of everyone affected by bowel cancer.

Main responsibilities

Delivering quality account management

- Managing relationships with your own portfolio of existing corporate partners, providing day-to-day management and support to maximise the impact and funds raised
- Providing hands on support for the Senior Corporate Partnership Officers with the stewardship and delivery of their larger, strategic corporate partnerships
- Ensuring high-quality events management. This includes supporting participants in events and ones that companies are running on our behalf
- Demonstrating excellent stewardship, keeping in regular contact with partners via email, phone calls and meetings building strong, trusted relationships
- Celebrating our partners by making sure they are thanked for any support and receive compelling and timely reports and updates on the charity's work



• Offering partners inspiring opportunities to connect with our work, such as challenges, arranging awareness talks or attending events

Securing new business

- Supporting the Senior Strategic Partnerships Manager and Senior Corporate Partnership Officers to build a pipeline of companies with the strongest alignment and biggest potential to make a difference to the bowel cancer community
- Identifying, researching, and generating new funding opportunities up to a partnership value of £15k
- Proactively securing meetings with prospective supporters and seek new opportunities within your existing portfolio
- Leading compelling and impactful proposals and presentations for your prospects
- Supporting the creation of a suite of compelling resources that demonstrate the benefits of partnering with the charity
- Where and when appropriate, maximise support for the charity through the receipt of gifts in-kind or pro-bono support

Working collaboratively

- Working closely with other teams e.g. Services, Comms, Events, Research to gather information and maximise the right opportunities
- Working on projects to enhance the performance of the Partnerships and Philanthropy team. For example, improving our storytelling and stewardship
- Support the Senior Strategic Corporate Partnerships Manager and the Senior Corporate Partnerships Officer's by helping with the creation and delivery of proposals, pitches and stewardship for our larger partnerships



- Working closely with the Team Assistant who supports the team across the board. For example, by completing prospect research and due diligence
- Supporting the briefing of senior stakeholders for partnership-related speeches, meetings, events etc
- Ensuring our team's comms and collateral most impactfully articulates our case for support and best supports the needs of our partnerships
- Keeping on top of external trends and attending external networking and training events where relevant

Keeping organised and driving innovation

- Maintaining excellent records of your work such as keeping our database up to date, following and enhancing processes
- Feeding into monthly reporting against objectives, quarterly reforecasting and income and expenditure budget
- Contributing to the ongoing development and execution of the Corporate Partnerships Strategy
