## Background

- at least one associate who can support our work to deliver Data Maturity Assessments within organisations, including hosting engaging, online workshops with staff to kick-off organisation-wide Assessments.
- at least one associate who can support our consultancy work developing data strategies for nonprofit organisations

• At least one associate with expertise in impact and evaluation (including developing theories of change)

- Coaching and mentoring skills
- Project management and delivery

- Knowledge and understanding of data maturity especially in nonprofit organisations
- Readiness to learn about how we talk about and share concepts and tools around data maturity
- Good writing skills (clarity, logic and structure)
- Attention to detail, care in presentation of proposals/ documents/ reports etc.
- Digital skills (Zoom/ Teams, online whiteboard tools, online team communication platforms)
- Awareness of the varying nonprofit context across the UK
- UK-based, able to work remotely as part of a distributed team
- Have the right to work in the UK
- Already set up as a freelancer so that you can invoice Data Orchard for your time
- At least six months experience as a freelancer with a track record of the successful delivery of projects on a freelance basis
- You must provide your own equipment which must be secured in line with our ICT policies.
- Most associates will be required to use Microsoft Office documents in the delivery of their contracts.

- Experience using our Data Maturity Assessment Tool and / or our Data Maturity Framework
- Experience delivering data strategies within nonprofit organisations
- Certified Data Management Professional qualified

- Experience of data analysis, data science, data engineering and/or data architecture
- Experience of developing theories of change with organisations
