The Chair will oversee the charity's governance, strategic development, and financial management while embodying the values and passion for empowering young women and girls as well as complying with the Charity Commission and other regulatory bodies requirements.

As our new Chair, you will lead the Board, working with the CEO to raise the profile of Goals 4 Girls, represent us externally & support the continued development of the organisation. You will play an important role in consolidating a strong strategic position & effectively promoting the voice of girls both nationally and regionally, driving change & breaking down barriers for young women in football.





#### **KEY RESPONSIBILITIES**

- Formulate, review, and drive forward strategic plans and policies in alignment with our goals of empowering young women.
- Maintain rigorous financial oversight and ensure transparent communication about the charities' financial position.
- Lead the board effectively, ensuring all trustees are fully engaged and have the resources they need to perform optimally.
- Serve as a primary spokesperson for the Charity, advocating for young women and girls in sports and education at high-level functions and with key stakeholders.
- Support and guide the CEO/MD and other board members in developing and implementing effective strategies and making impactful decisions.
- Appointment and management of the Trustee Board & CEO.

- Exclusive commitment to Goals 4 Girls, not holding chair or trustee roles on other boards.
- Proven strategic leadership experience, ideally within the charity/non-profit sector.
- Strong understanding of governance, with a commitment to upholding the legal and fiduciary responsibilities of trusteeship.
- Excellent communication and interpersonal skills, capable of fostering collaboration and driving change.
- Strategic thinker with a keen interest in developing and supporting the Charities' business strategy.

### **COMMITMENT**

- The board meets quarterly; additional engagement is necessary for strategic reviews and subcommittee meetings.
- Consistent interaction with the CEO/MD and availability to staff and stakeholders as needed to support ongoing projects and initiatives.
- You will be appointed for a three-year term, with a commitment of two days per calendar month on average.
- The Chair is appointed by Trustees Board members and recruited by a sub-committee of the CEO and senior leadership team.
