About us

Belarus Free Theatre (BFT) is the only theatre in Europe banned by its government on political grounds. It was founded in 2005 in Minsk under Europe's last surviving dictatorship, and marked its 15th anniversary in 2020.

BFT is more than a theatre: alongside exploding taboos on the world stage, BFT has pioneered an award-winning global model of activism that unites artistic, geopolitical, environmental and human rights concerns, using theatre as the catalyst for social change. Described by The New York Times as, "one of the bravest and most inspired underground troupes on the planet", BFT has originated some of the world's most provocative and breathtakingly physical theatre – 50 brand new productions performed in more than 40 countries.

Since 2011, BFT has created award-winning theatre at-distance between London, home to co-founding Artistic Directors, Natalia Kaliada and Nicolai Khalezin, and Minsk, where their 20-strong permanent ensemble campaign, educate and perform every single day of the year. Awards include the Human Rights Prize of the French Republic (2007), the Atlantic Council Award (2011) and Vaclav Havel Prize for Creative Dissent (2018).

Natalia Kaliada and Nicolai Khalezin originated the Free Belarus Global Artistic Campaign and played a leading role in imposing targeted sanctions against Lukashenko and his regime in 2011 that led to the release of political prisoners in Belarus. Following the forced relocation of the company from Belarus caused by the regime's crackdown on pro-democracy organisations and the associated risks to the personal safety of the staff, Belarus Free Theatre has become a truly international company with ensemble members residing in the UK, Poland and Ukraine.

Purpose of the role of Finance Manager

The Finance Manager is responsible for the day to day operation, accuracy and integrity of the financial accounting systems within the organisation. They are responsible for producing monthly accounts, undertaking variance analysis and implementing financial controls. They will work with the Executive Director.

The post holder will have ambition and enthusiasm to drive change in the department to meet the needs of an evolving organisation.



Responsibilities

Management and control of the finance function, completion of all finance tasks including financial and management accounting.

Financial Planning

 Work as necessary with the Executive Director in drawing up annual company budgets, production budgets, annual operating plans and cash-flows, and long-term financial planning.

Monthly Management Accounts

- Report against annual budget on a monthly basis.
- Accuracy and completeness of data input
- Maintaining Purchase ledger and supplier information.
- Supplier payments.
- Petty cash payments, control, reconciliation and filing.
- Assisting on the export and creation of financial reporting.

Reporting and Accounts

- All financial accounting duties.
- Production of draft Monthly Management accounts for the Belarus Free Theatre.
- Balance sheet and control account reconciliation, preparing draft TB, reconciliation of income from productions, members and individual givers, sponsors, other sources of income. Bank reconciliation.
- Foreign exchange reconciliation.
- Prepare draft production accounts at the end of each show.
- Work with budget holders to keep monitoring systems up to date, ensure accuracy and completeness of records, identify variances and discrepancies.
- Draft Theatre Tax Relief returns.

Annual Audit

- Overseeing the preparation of the annual audit pack and the statutory audit process.
- Management of the annual audit, liaising with BFT's auditors.
- Preparation of fixed asset schedule, payroll and VAT reconciliation.
- Reconciliation of all balance sheet control accounts.
- Preparation of draft annual accounts (Management accounts).
- Ensure compliance with all reporting obligations including Companies House and Charity Commission.

Payroll and Pensions

- Prepare monthly payroll, cross-check payroll is prepared correctly with line manager. Variance analysis payroll vs salaries budget.
- Ensure compliance with payroll legislation and that adequate operating systems are in place
- Key contact with pensions providers.
- Preparation of calculations relating to Foreign entertainers.

General

- Implement Financial Controls across the organisation, plan and undertake internal audits as required.
- Monitoring bank accounts, balances, preparation of inter-bank transfers to maximise interest from cash resources.
- Any other financial duties as required by BFT.

They will be a good communicator, with the ability to work with a range of staff across all departments, have excellent analytical and spreadsheet skills, hands on experience as well as a formal accounting qualification (or part qualification) such as AAT or ACCA/CIMA.

- A good communicator and advocate for the department
