

#### **Role purpose**

Working within the Training and Consultancy team to deliver training to Employers and Careers/Employability professionals with the primary purpose of delivering training at scale to maximise reach and impact with a range of audiences.

Working within the organisation to develop and deliver high quality training products both in person and through online platforms.

Trainers will specialise in delivering training, providing expertise knowledge to support autistic young people and adults to thrive within the workplace driving a collective movement for change. The role will support employers and professionals to become autism confident, through the delivery of training suited to set briefs for individual organisations as well as online webinars, lunch and learns and sessions to ensure the services they offer are inclusive and aligned to the Equality Act 2010.

#### Key accountabilities and dimensions

#### Training delivery and development:

- Deliver engaging and interactive training in a range of settings as well as online, with a particular focus on Employers and careers professionals. Delivery to be in person and online.
- Using autism knowledge and expertise to design bespoke training products, or adapt existing content, to support their understanding of autism and improve inclusive practice
- Contribute to the creation and delivery of digital learning content to be utilised by external organisations, including employers and corporate clients, health and social care and education sectors.
- Understanding and communicating clear client training briefs to develop and deliver interactions to meet these objectives (including training, webinars, lunch and learns etc)
- Contribute to National Services team projects in response to training requests
- Ability to be flexible in travelling to different locations and working with a range of different audiences
- To train AaA internal staff on relevant training courses to share expertise and



knowledge internally where applicable

- Responsible for effective and timely professional communication, orally and in writing with clients, colleagues and stakeholders
- Responsible for capturing and monitoring evaluation of delivery and recording outcomes
- Responsible for managing own workload and delivering high quality services independently
- Working proactively with colleagues and wider teams including Youth Participation, Marketing and Fundraising.

#### **Co-delivery:**

- Adhere to the highest values of co-design and participation, contributing to Ambitious about Autism's (AaA) aims to ensure that the voices of autistic children and young people are heard in the development of the project and resources
- Overseeing the development and management of recruiting, developing, and supporting autistic young people to become co-trainers where applicable
- Contribute to the creation and delivery of digital learning content in collaboration with autistic young people and external partners
- Contribute to the creation of training content, materials and resources in collaboration with autistic young people
- Ensuring training materials and resources are fully accessible to autistic young people including individuals with co-occurring learning disabilities or other co-occurring condition

#### Additional duties

- Demonstrate a continual commitment to safeguarding and promoting the welfare of children and young people.
- To uphold Ambitious about Autism policies to protect and safeguard pupils in order to secure their health, safety and wellbeing.
- Demonstrate a continual commitment to the promotion of diversity initiatives and the sharing of best practice in line with Ambitious about Autisms Equality, Diversity and Inclusion policy and procedures.
- Ensure the highest degree of confidentiality and data protection of all materials
- Demonstrate the vision and values of Ambitious about Autism in everyday work and practice, upholding the ethos of challenge and support where all pupils/learners can reach their full potential and maximise their engagement in learning.
