Founded in 1989, Young Citizens is a national education charity working to enable more quality, inspiring, active citizenship education for children and young people in the UK. We operate as a crucial support system for young people and educators alike. Through a range of initiatives, including education programmes such as the Make a Difference Challenge and Experts in Schools, and immersive learning experiences such as the National Bar Mock Trials, Young Citizens actively engages over 500,000 children aged between five and 18 every year.

We believe that Britain's future depends on equipping the next generation with the skills, knowledge and confidence to participate actively in society. With democracy under pressure from many directions, our work has never been more important.

Our vision is a society where people are empowered to participate in and shape their communities and institutions for a more inclusive, accessible, and thriving democracy. We help young people become active and engaged citizens, able to contribute positively to their communities – locally, nationally and globally.



Sources of income for Young Citizens

In 2010, around 60% of our income came from central government grants. Today, this has reduced to zero. We have diversified our income sources, as we develop a new business model.



Over the next few years we are aiming to further diversify our income sources, making our programmes and materials available to a wider group of young people who will become active citizens of the future. At the same time we want to engage more funders in supporting our work through financial and volunteering support.

Role Summary

This is a dynamic new role which will play a key part in our strategy for income growth and diversification, supporting our Senior Income Generation Manager to bring in income, with a particular focus on Trusts and Foundations and individuals.

The ideal candidate will have experience with fundraising across varied audience groups, strong bid-writing skills and excellent written and verbal communication skills. You will bring energy and a real affinity for our work inspiring active citizens of the future.

Responsibilities

General fundraising

- Support the Senior Income Generation Manager in implementing the income generation strategy
- Work with our Education Team to develop funding propositions
- Provide a high standard of stewardship to all our audiences
- Work with the Finance Team to ensure Gift Aid claims are made and records kept
- Ensure fundraising activity is recorded on our CRM system so we can report on income and pipeline.

Grant funders

- Managing and maintaining relationships with our existing grant funders, to maximise relationships and long-term income growth
- Identifying prospects among trusts and foundations, researching and writing tailored bids to support our education activities and core funding needs
- Reporting back to funders, ensuring accuracy, impact focus and alignment with their reporting requirements.

Individual funders

- Develop supporter journeys for our small group of individual donors
- Work with other team members including our Comms Manager to identify potential new audiences and to target communications to build our supporter base
- Create opportunities for giving and communications that engage and inspire support.

General

- Any other duties that might be reasonably required to ensure an effective, positive team culture and charity success.
