MAIN PURPOSE:

NCT is a charity committed to social justice and Equity and Diversity, believing inclusion is everyone's responsibility. We believe we all have a collective responsibility to demonstrate our commitment to celebrate diversity, challenge inequality and build an inclusive workforce and environment, so all our people can thrive, and we can best represent and meet the needs of the pregnant women, new parents, families and communities we serve.

NCT are delighted to be commissioned to deliver a programme of work including infant feeding peer support and parenting courses for families throughout the Hackney region. We are seeking a capable service delivery manager who is passionate about supporting parents and infant feeding to lead on this project. Our services will include:

Peer led infant feeding peer support in the community

This project will train Peers who will go on to support across community and healthcare drop-ins, Homerton Hospital (early pregnancy meetings, postnatal and neonatal wards) as well as provide online support, telephone support and home visits. Peers will all receive accredited training to provide support to other parents whether that's sharing their breastfeeding and infant feeding knowledge, welcoming parents or providing social interaction to those they support.

Parenting courses for families with child/ren under the age of 2 years.

The Empowering Parents Empowering Communities (EPEC) project is a community-based programme, training staff and parent volunteers to deliver parenting courses across Hackney Borough. The courses are designed to improve access to effective parenting support particularly for families in disadvantaged neighbourhoods and excluded communities.

This is a key post to help NCT broaden its reach and relevance to parents of all backgrounds and enable them to have a life enhancing experience of becoming a parent.

The postholder will be responsible for the building, ongoing development and evaluation of the programme ensuring it is accessible and will hold stakeholder and commissioner relationships

JUDGEMENT AND DECISION MAKING

- Liaising and communicating with people at all levels is essential. This includes parents, NCT internal and external staff, Peer Support Trainers, NCT Practitioners, volunteers, Health Professionals, and other stakeholders.
- A professional approach must be maintained at all times.

AUTHORITY/SUPERVISION RECEIVED:

- Clear objectives and targets will be set, but the post holder will be required to use their initiative and work unsupervised, in order to achieve these objectives.
- Regular Teams meetings will be held, and line manager support is available when required.

MAIN RESPONSIBILITIES & DUTIES:

Lead on perinatal peer support across the region

- Provide line management and support to direct line reports and leadership for the project.
- Establish and maintain a good working knowledge and understanding of the local demographics of parents in the Hackney area and local services that support communities that are marginalised to most effectively signpost.
- Engage with underrepresented communities through networking with other local organisations.
- Set up and manage Parent Focus Groups to ensure that the programme is accessible and meet the needs or local parents.
- Act as local designated Safeguarding lead. Ensuring any safeguarding concerns are escalated and managed in line with NCT Safeguarding Policy and local safeguarding requirements.

Data Collection and Reporting

- Report progress on project status, timelines and delivery against key performance indicators.
- Ensure that data collection and feedback is collected in line with NCT data protection policies and processes.

- Prepare reports as required by commissioners and NCT.
- Attend internal/external project review meetings (quarterly), to assess progress made and to agree how the project can be proactively improved further. This will include raising awareness of the programme and needs of those accessing the service, identifying gaps and improvements in service provision.

External Engagement

- Attend and participate at the local Infant Feeding strategy group.
- Found/participate in/chair other local perinatal networking/task and finish projects, so that the programme is an integral part of the local perinatal and infant feeding provision landscape, and is able to advocate for and chaperone perinatal service users at a strategic level, raising the profile of NCT's perinatal offer locally and nationally.
- Map and build relationships with potential local commissioners in order to secure continuation funding/new contracts.
- Provide a point of contact for local media queries, consulting with the communications department in order to publicise and promote local service developments and partnerships.
- Be able to travel around the area to meetings and groups.

Provide visible leadership to, and role modelling of, our commitments to celebrate diversity and challenge inequality by building an inclusive and positive working culture and environment, so all our people can thrive.

Any other duties as requested by the Commissioned Services Manager.
