## Development and Alumni Engagement (DAE)

DAE is led by Liesl Elder who, as Chief Development and Alumni Engagement Officer at the University of Oxford, reports directly to the Vice-Chancellor. DAE's mission is to help secure philanthropic support for the University, and build an engaged, informed and active alumni community. Through working in partnership with academic, development, and alumni colleagues throughout the collegiate University, DAE builds enduring relationships with external constituencies – including alumni, non-alumni, corporate and foundation donors – and increases financial support for agreed academic priorities.

The office is one of the central administrative departments of the University, collectively known as University Administration and Services. Due to the nature of its work, DAE collaborates closely with a number of other units and teams, particularly Public Affairs, Finance, Research and Legal.

In 2019, the University and the colleges completed the *Oxford Thinking Campaign*, which raised £3.34bn, and is the most successful higher education fundraising campaign in Europe. The University is currently planning its next major campaign and, as a member of DAE, the post holder will have a key role to play in helping realise its successful delivery.

In addition to front-line fundraising and alumni engagement staff, DAE has a number of teams that cover particular support functions. These include:

- Research
- International Engagement
- Development and Alumni Relations Systems (DARS) (which supports the Development and Alumni Relations database)
- Communications
- Marketing and Insights

It also works closely with Gift Registry, part of the Finance Division, which records and processes donations received by the University and on behalf of colleges. In addition, there are four overseas offices whose remit includes development and alumni engagement; these offices are located in North America, Japan, Hong Kong, and Switzerland.

#### The role

Purpose: To work as a member of the Development and Alumni Engagement Prospect Research

Team in providing research, analysis, and due diligence on potential and actual donors to the University, both individuals and organisations, and identifying potential new

donors capable of making major gifts.

The post holder will be able to use the support services provided (accounting, database, communications, stewardship and research). The post holder will be based in central Oxford, but they may be able to agree a pattern of regular remote working with their line manager.

The line manager will regularly review progress. There may be opportunities for career development within the office structure. DAE seeks to support and encourage staff to help them reach their potential, providing access to appropriate courses and training whenever possible, as well as a comprehensive induction process.

DAE's work covers a wide range of activities and priorities which will inevitably change from day to day. All staff operate as a team, and, while each has their own responsibilities, they are expected to assist each other in peak periods. The post holder will need to become conversant with the University as a whole and especially with the numerous academic staff and volunteers.

#### **Development and Alumni Engagement values**

## Responsibilities

The duties of the post are set out as they are envisaged at present, but it will be important for the person appointed to be versatile and adaptable, and able to contribute to the development of the fundraising and alumni engagement functions of the collegiate University.

The main duties of this post will be as follows:

- Researching and writing briefings on people, companies, foundations and trusts, tailored to requests and completed to deadlines. These vary greatly in depth according to their purpose, and include in-depth research for the use of the University's leadership including Vice-Chancellor, Pro-Vice-Chancellors, Chief Development and Alumni Engagement Officer, as well as colleagues in Development and Alumni Engagement, and others. This research directly informs the University's decisions about its potential philanthropic engagements, and their potential financial value
- Researching and compiling information for the University's risk assessment and donations and funding
  acceptance process, including regular production of complex reports for the Committee to Review Donations
  and Research Funding. This involves identifying and summarising potential legal, financial and reputational
  risks to the University which inform decisions on whether the University will accept or reject major gifts and
  funding
- Researching and identifying potential donors with whom the University will aim to develop significant
  philanthropic relationships. These will be drawn from several groups: high net-worth individuals (both alumni
  and non-alumni), the corporate sector, trusts and foundations and other bodies from which funding may be
  obtained
- Building successful relationships with staff in Development and Alumni Engagement and other colleagues
  working in development roles. Providing advice, guidance and training on research, due diligence and
  prospect data matters, which may be in a one-to-one or group setting
- As required, assisting with responding to incoming requests and the distribution of tasks within the team
- Using the Development and Alumni Engagement database expertly (training is provided) to understand our relationships, create new opportunities, and to capture information effectively
- Monitoring the philanthropic and business environments, providing regular and ad hoc news updates.
- Maintaining and developing our research and business information resources, and identifying potentially useful resources and tools
- Answering general enquiries from across the University relevant to the work of the team

You will carry out any other duties which are requested by the line manager and are commensurate with the grade of this post.

#### Selection criteria

#### Essential selection criteria

- Degree or equivalent, or able to offer the equivalent in terms of professional training and experience
- Experience of prospect research in a fundraising organisation OR experience in a research-focused or information-focused role in a business setting such as consultancy, law, banking or professional services
- Excellent research skills; the ability to plan a research strategy and to adopt creative approaches to research wherever useful
- Excellent standard of written and spoken English, good communication skills, and the ability to produce clear, accurate and concise written reports
- Enjoyment of working collaboratively in a team, with the ability to build successful relationships within the team and beyond it
- Willingness to be adaptable, and capability of switching effectively between work of different types whilst maintaining care and attention to detail. Commitment to providing a high quality service
- Good knowledge of the overall business environment and of current affairs
- Numeracy and the ability to understand and explain financial information
- Tact and discretion

#### Desirable selection criteria

- Experience of reputational due diligence research
- Experience of major gift fundraising, particularly within a Higher Education setting
- Experience of using online subscription-based news databases, such as Lexis-Nexis or Factiva, and company databases, together with advanced Internet searching skills
- Successful experience of providing, and willingness to provide, training to individuals and groups of different sizes
