POST: Youth Worker

WORKING PATTERN: 30 hours per week (with a minimum of 2 evenings per week)

JOB PURPOSE: To work with the children's youth and community team to deliver a full

programme of activities and opportunities that support the personal and social development of the children and young people within the local community.

RESPONSIBILITIES:

1. Work alongside the Lead Youth Worker to design and deliver a full youth programme that meets the needs and interests of the local community.

- 2. Be proactive in planning and delivering activities and engaging with young people within our Academies and wider community.
- 3. Deliver informal education opportunities and 1:1 mentoring within sessions and the wider community.
- 4. Record all activity on our data management system.
- 5. Promote and safeguard the welfare of children and young people you come into contact with.
- 6. Actively engage in the learning and professional development courses provided as part of this employment.

SPECIFIC DUTIES:

- Alongside the Lead Youth Worker, design, plan and deliver a weekly open access session for young people in Lawrence Weston.
- Work with the Lead Youth Worker to develop and deliver a high quality 1:1 service through our Bridging programme across North Bristol.
- Deliver innovative activities for young people, in the community and our academies in line with the local and city-wide Youth Vision.
- Deliver outreach/detached youth work sessions within the local area to engage young people across the community.
- Support local youth events.
- Work with a focus group of young people to inform the project's monitoring and evaluation
- Build appropriate relationships with young people to support their personal and social development.
- Support young people to engage in volunteering opportunities.
- Deliver 1:1 mentoring for young people across the Community Hub in partnership with our Academies and local authority.
- Use debriefs and practical learning to inform future curriculum and activity programmes.



- To write short reports to show the impact and outcomes of your planned activities.
- Keep up-to-date records of any sessions you run with young people.

GENERAL DUTIES:

- Be part of the planning and development of new and innovative programmes for young people.
- Engage in all forms of supervision offered by Oasis e.g. reflective practice, clinical supervision.
- Work closely with staff and volunteers to run the youth project sessions and support their development as part of a wider team.
- Promote and develop a positive culture and ensure that diversity within each community is recognised and respected.
- Lead by example and be a positive role model.
- Participate in debriefs, team meetings and termly plans.
- Meet regularly with Line Managers and mentors as agreed.
- Work positively and inclusively with partner agencies to ensure a partnership and working together approach is actively promoted.
- Undertake training as required.
- Undertake home visits as required.
- · Open and close community buildings.
- Ensure Oasis policies and procedures are followed at all times.
- Post holder must have access to their own transport and be easily able to travel around the North Bristol area.
