## **About the Role**

The part-time (21 hours) Corporate and Partnerships Fundraiser will raise the profile and awareness of CamSight and increase income through developing and securing a range of funding streams including Corporates and their employees whilst developing new relationships and partnerships. The post holder will help to develop and ensure the effective delivery of the corporate and partnerships fundraising strategy to generate sustainable income from new and existing partnerships.

The role will help grow our portfolio of partnerships, working collaboratively to explore ideas and launch new initiatives to help us achieve our mission. The role plays an important part in helping us to meet our fundraising targets and increasing participation and engagement in our fundraising activities.

We are also currently recruiting for a part-time (21 hours) Community and Events Fundraiser but would welcome applicants interested in a full-time role (35 hours a week) covering both job descriptions. If this is of interest, please make this clear in your covering letter.

# **Specific Tasks**

### General

- Work alongside the Head of Business Development and Community and Events fundraiser to develop and promote successful and engaging fundraising initiatives, campaigns, and events to engage and encourage potential supporters, using research to spot trends and popular initiatives.
- Develop and follow processes and systems to ensure the effective management of all relevant information, including maintaining and taking responsibility for accurate information on the charity's database and the corporate partners section of the website.
- Analyse the potential risks and benefits of fundraising events/activities considering risk, time/cost ratios, and overall ROI, to focus effort accordingly.
- Ensure all associated activities are compliant with charity law, regulatory requirements, and best practice, including the Data Protection Act and GDPR.
- Be a positive ambassador for CamSight, promoting and raising awareness of its services and delivering engaging fundraising presentations to potential and existing supporters.
- Be an active and supportive member of the Fundraising Team and wider CamSight team, contributing to the team's development and working collaboratively with colleagues to maximise cross-working opportunities.
- Work collaboratively with the Marketing and Communications Officer to develop and implement marketing and social media plans for all events/activities.

## Corporate

- Responsible for the development of Corporate Fundraising initiatives.
- Identify appropriate corporate partners for strategic partnerships, sponsorship, and other corporate fundraising activities.
- Research and analyse corporate financial and other information from a wide range of sources to ensure approaches are tailored, targeted and of the highest quality.
- Work with corporate partners to increase understanding across their businesses, identify new opportunities for engagement and explore new initiatives and ideas.
- Develop and implement tailored employee fundraising plans for corporate partners, managing subsequent fundraising activities such as golf days, office fundraising, involvement in challenge events and new fundraising products.
