





ECOMMERCE TRADING MANAGER - JOB DESCRIPTION

As Ecommerce Trading Manager you will be responsible for identifying goods donated to St Barnabas, Martlets and Chestnut Tree House that are best placed for sale through our ecommerce channels in order to realise the best profit for the organisation. You should have an eye for unique, high-end, or niche products and be skilled at listing items for sale within an online environment. This is an exciting time for charity ecommerce and this role will enable you to be instrumental in developing and delivering a strategic direction for this important income stream in order to increase profitability.

What you'll do:

- Manage the ecommerce trading operation and team across the hospice group, maximising income and profit contribution, setting and managing annual budgets.
- Working with the Director of Public Fundraising and Retail, develop and implement a 3-year strategy for growing ecommerce income and profitability.
- Monitor and analyse performance, providing reports on a monthly and quarterly basis covering relevant KPI's, sales and profit data.
- Manage and develop staff and volunteer team necessary for delivering growth, sales and the highest standard of customer service.
- Working with the Marketing and Communications team, develop marketing campaigns, and PR to drive sales and donations for online.
- Train and develop your team to ensure the highest quality listings including photography specific to online sales platforms, effective and accurate written descriptions designed to appeal to both collectors and broad audiences. Monitor and review that standards are being met. Attend sector training, networking and conferences to ensure knowledge is up to date.
- To manage the ordering and processing of new goods, ensuring adequate stock and ranges as agreed with the Head of Trading.
- To manage, maintain, adopt and review online systems and platforms with the purpose of maximising efficiency and income.
- To manage, maintain, adopt and review logistics systems that provide the best value and service standards for the organisation and ecommerce customers. Manage stock and inventory to ensure effective use of space, stock flow and to minimise shrinkage.
- Be responsible for growing and developing your team, providing them with opportunities to expand upon and demonstrate their skills. Ensure that annual appraisals and objective setting is carried out for all team members and that performance management is carried out where necessary.
- Appoint and manage supplier relationships. Negotiate contracts and hold them to account to ensure effective and efficient delivery.
- Ensure processes and practices are in place to provide excellent customer care to ecommerce shoppers and donors. Investigate and respond to feedback and complaints.







What you'll bring:

- Experience in an operational retail management role desirable
- Demonstrable specialist knowledge and experience in managing an online sales operation
- An understanding of online sales platforms, stock management and inventory systems
- Excellent computer skills including use of Outlook, Word, Excel and online sales platforms
- Ability to prioritise and organise competing demands and work under pressure
- People management including ability to motivate and develop direct reports and to align objectives with organisational strategy.
- Experience of recording, gathering, organising, presenting, and evaluating information to improve performance and aid decision making.
- Proven experience of providing outstanding customer care
- Able to communicate clearly in person and in writing with the public, staff and volunteers
- Experience of EPOS systems and retail office systems, stock management and cash handling/retail accounting systems
- Excellent communication skills and experience in delivering training in a retail environment
- Willing to work variable hours, including some evenings and weekends
