Role Description – Young Persons Project Support Worker

Purpose of job role

The role of the Young Persons emotional support worker is to help co-ordinate and deliver the Young Peoples mental health service in Schools and in the community of Haringey for the Myends programme. This project is new and will work with young people in schools and in the community that transitioning in mental health services and those not already in the mental health system experiencing multiple disadvantages and deprivation and some of whom may or may not be experiencing mental ill health.

The role of the post is to engage and support the client group to access better outcomes and support them to stay in school and ensure that are better at looking after their own wellbeing and more resilient. With your manager you will help ensure that the funder's requirements are met and good outcomes demonstrated for all clients. Ensuring the support in schools /community and associated activities are implemented in line with our

contract funding requirements. Outreach work is a key element of engaging young people on the program as is liaison with their support networks professional or otherwise.

Responsibilities and Requirements:

- Carry a case load of young people needing support and act as their key worker actively engaging them and identifying additional support, counselling and other external support mechanisms that will help them achieve positive outcomes.
- Track project deliverables using appropriate tools. E.G. outcome star, Wellness recovery action plans (wrap's) support plans, and pathways plans etc.
- Present reports to your manager defining all client's progress, problems and solutions and ensure that all files and data are kept current.
- Liaise with care coordinators, social workers and other mental health professionals involved in the treatment /care of your clients.
- A real passion and commitment to affecting change in the lives of others particularly young people
- Experience in delivering youth orientated projects with hard to reach or engage young people.
- Experience of working with challenging/vulnerable young people.
- Demonstrable understanding of: Child and Adolescent mental health,
 Adult mental health and services
 Child protection, contextual safeguarding
 Safeguarding vulnerable adults.
- Flexible working conditions are a requirement of the post.
- Good knowledge of IT (Information Technology) systems.
