Background information on NEA

National Energy Action (NEA) is the leading national fuel poverty charity.

NEA is the national charity that works to eradicate fuel poverty and campaigns for greater investment in energy efficiency to help those on low incomes or who are vulnerable, to stay affordably warm and well. NEA works in partnership with central and local government, energy and water utilities, housing providers, consumer groups and voluntary organisations, to promote energy efficiency with the aim of bringing social, environmental, housing and employment benefits to communities. NEA currently employs over 170 staff at our national headquarters in Newcastle upon Tyne and in regional offices across England, Wales and Northern Ireland.

NEA achieves its objectives through:

- Developing and managing practical projects which demonstrate innovative ways of tackling fuel poverty and bringing the wider benefits of energy efficiency to communities.
- Undertaking research and analysis into the causes and extent of fuel poverty and the policies which address the problem.
- Providing advice and guidance on good practice in delivering energy efficiency services to households.
- Developing national qualifications and managing their implementation to improve the standards of practical work and the quality of energy advice.
- Campaigning to ensure social and environmental objectives are brought together under national energy efficiency programmes.

Policy and Advocacy Directorate

A part of the Policy and Advocacy Directorate, the Research Team works across the fields of fuel poverty, domestic energy and net zero, and social policy areas of housing and health. It delivers social research and evaluation that examines the causes and consequences of fuel poverty, energy vulnerability and inequality and uses empirical research and evidence-based insights to represent the lived realities of households across the UK and, assess the impact of associated policy and practice interventions.

About the post

The position is based within a small but highly effective social research team managed by NEA's Head of Research.

You will be part of a committed and caring team of professionals who work hard to ensure that the necessary evidence and insights are available to develop solutions that mean everyone can afford to live on a warm and safe home.

The Team is strengthened by working closely with colleagues within NEA and with external partners. This collective breadth of insight ensures that NEA is an expert voice on fuel poverty and one that puts vulnerable households and consumers at the centre of policy and practice, not least in ensuring the transition to net zero is one that is fair and just.

Supported by NEA's Head of Research you will join a highly focussed and dedicated Team delivering a varied work programme that focusses on NEA's strategic priorities to:

- 1) **Tackle the Worst First**: ensuring households in the most need receive adequate support, including decarbonisation of heat as an opportunity to drive forward warm & safe homes.
- 2) Ensure that Support is Guaranteed: appropriate advice and support is available via industry, utility and statutory action and that those on the lowest incomes receive protection from distributive policy costs.
- 3) Achieve a decade of delivery: focussing on national strategies and targets to address coldrelated morbidity & mortality, national and regional enforcement.

As Research and Policy Officer, you will work and collaborate on the design, development and delivery of social research and evaluation projects that support the charity's strategic aims and policy advocacy priorities. As well as undertaking mixed methods social research that foregrounds the lived experience of households, you will develop research-user and stakeholder relationships and integrate evidence-based insights from across the charity's work programmes to influence and have impact across multiple areas of social policy and practice.

Term and Conditions of Employment

Salary: The salary range is **£32,641 - £37,304** (SO1-SO2 Scale, Points 23-28).

New appointments will usually begin at the starting point of the

scale.

Hours of work: 37 hours per week, Monday to Friday on a flexi-time basis;

alternatively, we will consider part-time hours on a Job Share basis. Applicants must be willing to work away from home as required. In the event of work undertaken on evenings or weekends, and which may involve travel away from the office, time off in lieu of payment is given.

Holidays: 25 days, plus 3 additional days in the Christmas/New year period,

plus all public holidays per annum.

Pensions and other benefits: NEA offers a money-purchase, non-contributory pension scheme.

11½% of basic salary will be paid by NEA into the pension. NEA also offers death-in-service cover to state retirement age and enhanced

sick pay.
