

The Green Estate is a community interest company whose purpose is to grow green and resilient urban places for people and nature to thrive. We are one of the first 15 organisations who the King selected for the prestigious King's Award for Enterprise in Sustainable Development. Our 2030 goal is to become a national urban resilience demonstrator.

This is a new and pivotal leadership role at The Green Estate at an exciting time of change. With a new CE, Leadership Team, Board and Strategy in place we are seeking an experienced professional fundraiser to develop and deliver our first fundraising and investment strategy to help us achieve our mission and 2030 goal!

This will involve delivering ambitious fundraising targets from a range of sources including grants, donations, corporate and philanthropic fundraising and investment. The postholder will need to 'hold the pen' and produce high quality funding applications and investment proposals.

The postholder will provide leadership and business development support for expert and talented service managers and work with the rest of the Leadership team to grow the income, impact and influence of The Green Estate.

The postholder will need to be commercially minded, have an excellent track record and expertise in fundraising from multiple sources and have a commitment to our mission and values. This role will require significant fundraising experience across multiple income streams, combined with leadership qualities and a track record of delivering ambitious fundraising targets and business growth

- Developing and implementing an ambitious growth fundraising and investment plan aligned with the strategy
- Build business models for our urban resilience communities and centre enterprises ensuring they are financially sustainable and generating profits for purpose.

- Build a robust fundraising pipeline encompassing major donors, corporate partnerships, grant applications and other income streams.
- Developing and maintaining a funding database and systems and procedures to support efficient and effective fundraising and regular reporting on ambitious fundraising targets
- Proactive approach to fundraising to ensure The Green Estate is well informed on the latest opportunities and are well connected into relevant networks and funding bodies.
