

#### The MAAC Group consists of:

- The parent charity **Midlands Air Ambulance Charity (MAAC)**, governed by the MAAC Board of Trustees.
- The charity's wholly owned trading subsidiary **Midlands Air Ambulance Trading Ltd (MAATL)**, governed by the MAATL Board of Directors.

#### **Midlands Air Ambulance Charity (MAAC)**

MAAC was formed in 1991 and provides a well-established, long serving, pre-hospital, helicopter-led emergency medical service across the six counties of Gloucestershire, Herefordshire, Shropshire, Staffordshire, the West Midlands and Worcestershire. We offer enhanced critical care provision, bringing hospital-level procedures and medicines and specialist Doctor and Critical Care Paramedic skills to the patient at the scene.



We operate three aircraft from locations across our geography, along with a fleet of Rapid Response Vehicles and Critical Care Cars in support of our mission. MAAC currently funds its services entirely by fundraising - raising circa £15 million each year to meet that cost. However, MAAC's five year strategy requires income growth and includes further income diversification.

We are a forward thinking, fast paced organisation comprising of many parts. We operate:

- By air and land as a healthcare provider specialising in pre-hospital emergency medicine (PHEM) with our fleet of 3 helicopters that are supported by our fleet of critical care rapid response vehicles.
- As a **registered charity**, our lifesaving service is enabled via a broad range of income generation activities, volunteering and corporate partnerships;

• As a **retail business with an expanding portfolio of shops across the region** and online sales platforms via our trading subsidiary MAATL.

In 2024 we celebrated our 33-year anniversary. **We are an independent healthcare provider registered with the Care Quality Commission (CQC) with an Outstanding rating across all of our airbases.** We employ our own Doctors and Critical Care Paramedics. In July 2023, we moved into our new purpose-built airbase and charity headquarters and in January 2024 we extended our operating hours to 24/7 – reaching more patients in their critical hour of need across the whole of the Midlands region.

# **Midlands Air Ambulance Trading Limited (MAATL)**

**MAATL** is a private limited company and a wholly owned subsidiary of the parent charity Midlands Air Ambulance Charity (MAAC). Profits from MAATL charity shops play a vital part in funding MAAC's helicopter-led emergency medical service.

MAATL celebrated its 12th anniversary in 2024 and has grown to currently nine stores i.e. **Gloucester**, Merry Hill, Newcastle-under-Lyme, Shrewsbury, Walsall, Wellington, West Bromwich, Stoke and Hereford. MAATL's retail portfolio also includes online operations (second hand goods e.g. eBay; MAAC merchandise sales). MAATL has ambitious plans to expand further.

MAATL's stores are managed by the Head of Retail and two Area Managers (North and South), and are resourced by employees (Shop Managers, Assistant Shop Managers, Sales Assistants) and volunteers. MAATL is a member of the Charity Retail Association.

#### MAAC GROUP STRATEGIC OBJECTIVES

We are in the middle of an exciting time in our organisation's development having launched a rolling fiveyear strategy in 2022. We are on a journey of significant transformational change and we have agreed some challenging ambitions – to ensure we effectively expand our activities to meet changing patient need and increasing demand for our independently funded 365-day 24/7 helicopter-led emergency medical service.

#### **Enabling Themes**

Our four strategic objectives are supported by four enabling themes: Innovation, Leadership, Environmental, Brand Engagement

#### **OUR IMPACT**

We are committed to providing the region's population with the best possible pre-hospital emergency medical service by land and air. We benefit the lives of six million people across all age groups, supporting diverse communities across a six-counties, comprising of urban conurbations and isolated rural areas.

Since 1991, we have responded to more than 75,000 missions, averaging 4,500 per year. On average, we reach patients within ten minutes, bringing the following interventions to the incident scene and giving patients the best chance of survival and recovery:

- Advanced clinical care and skillset via our critical care paramedics and pre-hospital emergency medicine doctors
- Enhanced medicines to further support pain relief and sedation
- Hospital-level equipment to undertake surgical procedures



• Blood products for patients who need transfusions

As part of our ongoing innovation, we recently introduced the following new equipment and drugs to expedite treatment and enhance patient care: Neonatal Resuscitation Equipment Bag; Prefilled syringes of Ketamine, Fentanyl and Metaraminol; Butterfly ultrasound devices; Platform iPhones - enabling diagnostics and patient record keeping.

#### **OUR GOVERNANCE**

**MAAC's Board of Trustees** is responsible for ensuring the parent charity MAAC is effectively governed and run, and that it achieves its charitable purposes for the public benefit.

As MAAC is both a registered charity and a Company Limited by Guarantee, Trustees have duties and responsibilities as a Charity Trustee and Company Director, working to charity and company law. MAAC's Board of Trustees maintain an on-going review of good governance, including an annual Board Effectiveness Review, with reference to standards and guidance from the Charity Commission, the Fundraising Regulator, Care Quality Commission, and other key bodies. MAAC has adopted and works to the Charity Governance Code. MAAC currently has four Board Committees: Audit and Risk Committee; HR and Renumeration Committee; Income Generation Committee; Clinical Standards Committee.

MAAC's Board of Trustees also have duties in regard to its wholly owned trading subsidiary MAATL. As part of their duties, Trustees must routinely monitor the performance of MAATL, and of the parent charity's investments in MAATL, with a view to ensuring the good and proper use of the charity's assets. The key purpose of MAATL is to raise funds for MAAC, and its effectiveness in doing this is naturally monitored.

**MAATL Board of Directors** is responsible for ensuring the charity's trading subsidiary company MAATL is effectively governed and run, and that it achieves its objectives. MAATL Directors are beholden to company law, including company director duties and responsibilities.

Whilst one of MAATL Directors duties is to promote the success of MAATL (e.g. increase profit), MAATL Directors must also be mindful of the implication of their decisions on the parent charity's objectives, brand and reputation.

### Midlands Air Ambulance Charity (MAAC) - Trustee Role Description

Midlands Air Ambulance Charity (MAAC) is both a registered charity and a Company Limited by Guarantee (i.e. a charitable company) therefore Trustees have duties and responsibilities as a Charity Trustee and Company Director (working to charity and company law). The Board of Trustees core role is a focus on governance, oversight, strategy, performance and assurance (not day to day management, which is delegated to the executive team).

As a Trustee, you will work collectively with other Trustees to ensure the charity is fulfilling its purposes as effectively as possible with responsible use of the resources available.

#### Example responsibilities include:

- Developing and approving the charity's strategic aims and objectives.
- Approval of the annual operating and capital expenditure budgets and any material changes to them.
- Approval of the annual report and accounts.
- Evaluating the charity's impact by measuring and assessing results, outputs and outcomes.
- Monitoring performance against the charity's strategic aims, objectives, business plans and budgets and ensuring that any necessary corrective action is taken.
- Oversight of the charity's operations, ensuring competent and prudent management; maintenance of sound management, planning and internal control systems; adequate accounting and other records; and compliance with MAAC's governing document, statutory and regulatory obligations.
- Approval of key policies.
- Ensuring effective risk management including receiving reports on, and reviewing the effectiveness of, the charity's risk and control processes to support its strategy and objectives;
- Ensuring the charity's values are reflected in all of its work, and that the ethos and culture of the organisation underpin the delivery of all activities.

#### We estimate the time commitment equates to circa 10 to 12 days per year, as outlined below:

- Four Board meetings a year, in person at MAAC HQ,10:00 to 13:00 (week days)
- Annual Board Away Day (MAAC Trustees and MAATL Directors together with the Senior Leadership Team).
