



- Attend meetings and residentials (online and in-person).

#### Our ideal Youth Consultant will:

- Aged between 16-25 years old (an occupational requirement to meet legitimate aim, Equality Act 2010).
- Live and have the right to work in the UK.
- Have the ability and skills to use ICT equipment.
- Have an understanding of youth work practice and youth participation.
- Have experience of youth work services or good knowledge on youth work and participation.
- The ability to work well with others and in a team.
- Be able to manage your own workload and display resilience.
- Have the ability to understand and identify the impact youth participation has on young people and their communities.
- Have an understanding of Equality, Equity and Diversity and Inclusion.
- Have good communication skills, and experience working with staff at different levels to develop reports, products, and insight.
- Have the ability to receive, input and analyse data, producing accurate and informative reports and written feedback.
- Good verbal and written communications skills with a strong attention to detail. Excellent knowledge of IT systems and Office 365.
- Can thrive in a team-oriented environment. Your ability to listen, share ideas, and support your colleagues will be vital to achieving our goals.

As the role will involve direct work with young people successful candidates over the age of 16 will be subject to an appropriate level DBS Check prior to starting their employment.

An offer of appointment will be made once candidates have been interviewed and will be subject to satisfactory completion of eligibility checks, including references, UK Right to Work and Enhanced DBS checks. If you are offered an appointment, you will receive a detailed summary of your main terms and conditions within your contract of employment. All roles have a six-month probationary period.

#### Hours

Part-Time 10 hours per month. The actual hours you work are flexible, however we will require you to commit to attending Tuesday evening meetings online via zoom.

#### Safeguarding

This role is subject to the provision of all child protection legislation, and all policies governing staff that work with children and vulnerable adults.
