Cord is an international peacebuilding charity working to make peace a reality where people don't have the freedom to exercise their rights. We work to build the relationship between those in power and local communities.

We believe that people flourish when all parts of society work together. Peaceful relationships make that possible. The simple act of talking begins a journey of growth which transforms mistrust, includes the excluded and turns adversaries into allies.

This vision, our mission and our values are inspired by the Christian faith and based on these values we work with and employ people of all faiths and none.

Cord has a long and proud history in working with communities worldwide to build their capacity for peace. We implement peacebuilding projects in challenging contexts with limited civic participation space. The programmes are often multi-sectoral with clear peacebuilding components and approaches.





The focus of our global strategy is on transforming dysfunctional relationships between those in power and citizens (like you or I) into those that create peaceful and inclusive societies where everyone can live free from fear and with the freedom to flourish

Our current country portfolio focuses on 8 highly sensitive contexts -Burundi, Uganda, Cambodia, Laos, Thailand, Myanmar, Vietnam & the Philippines.

We work with a wide range of civil society groups and powerholders (authorities, multinational businesses, faith leaders) in order to develop more constructive engagement.

This leads to real transformative change such as:

- survivors of sexual violence accessing justice
- stigmatised groups gaining access to healthcare
- indigenous peoples regaining rights to their land
- religious and ethnic minorities gaining freedom to express their beliefs





We are looking for someone to manage our Programme Development work. You will be someone passionate about the work Cord does and who can bring technical institutional funding expertise alongside peacebuilding knowledge to our small and committed team.

In this role you will lead the development of new programmes and institutional funding bids in line with Cord's peacebuilding approach and 5 main programme areas: 1) Empowering Women & Girls, 2) Addressing Fundamental freedoms, 3) Climate Change and the Environment, 4) Economic Empowerment and 5) Supporting stronger societies

The Programme Development Manager will lead on proposal submissions to Cord's key donors such as the EU, US State Department, GIZ, SDC, UN Peacebuilding Fund etc. You will be working closely with country teams to design and write proposals based on strong project designs. The role will also operate at a strategic level to shape how Cord communicates about its programmes and the added-value that Cord brings.

This role would suit someone with programme development and management experience working for an iNGO in peacebuilding who is looking to lead in proposal development and is able to manage a diverse global team in designing proposals to tight deadlines. You will be able to utilise evidence of impact to engage donors with Cord's work, and develop future programmes based on research and learning.



Key Responsibilities

Programme Development

- Contribute to developing Cord's 5 global thematic areas and identifying programme development opportunities in line with these
- Coordinate and manage an efficient and collaborative programme development process ensuring input from relevant teams at appropriate stages;
- Maintain an expert understanding of country contexts and lead on gathering qualitative and quantitative data to inform project designs (through desk-based research, needs assessments and partner meetings);
- Lead on designing new project concepts in line with Cord's five thematic areas which respond both to Cord's technical strengths and institutional donor and funding call priorities;

- Lead on producing high quality problem statements, intervention logics, theories of change, logical frameworks, activity plans, stakeholder and risk analysis for new projects;
- Lead on developing programme budgets with input from country teams and the Finance Manager.
- Maintain credible understanding of comparator organisations and projects to avoid duplication of interventions and ensure innovation;
- Advise country teams on relevant partnership development.
- In collaboration with the Head of Programme Development and Peacebuilding Support, contribute to the Country Strategy development Process



Key Responsibilities

Institutional Fundraising

- Lead on writing and submitting major institutional and match funding proposals and provide quality assurance of bids submitted by country teams;
- Implement Cord's Institutional Funding Strategy, including identifying and attending relevant meetings and conferences;
- Coordinate Cord's Trusts and Foundations approach, identifying targets, preparing resources and developing a plan of action
- Maintain and develop targeted relationships with existing and relevant new institutional donors;
- Maintain expert intelligence of institutional donor priorities and areas of interest in relation to Cord's Strategy and countries of operation;

- Coordinate and oversee a 'twin track' approach to influencing donors from the UK and in-country, and advise country teams on donor engagement tools;
- Where required, develop clear Match Funding Plans and oversee their implementation in the UK and country offices;
- Manage and maintain accurate pipeline databases of funding opportunities and application statuses and input these into relevant meetings;
- Oversee accurate timely proposal submission processes, including ensuring all relevant back up documentation and submission requirements are adhered to (e.g. EU PADOR, PROSPECT, PMS, SAMS etc).



Key Responsibilities

Communications and Visibility

- Coordinate a consistent approach to communications & visibility to key donors and stakeholders, writing materials where required.
- Liaise regularly with the Programme Quality Lead, to ensure a strong information flow from existing projects to feed donor/stakeholder updates
- Ensure all new project proposals have clear communications and visibility plans, and budget built in as per the Global Visibility & Communications Plan

 Produce external publications evidencing Cord's impact in relation to its Strategy;



- Higher degree and advanced understanding of human rights, peacebuilding or international development;
- Strong knowledge of current policy debates regarding the above, with ability to advocate and write credibly on such issues;
- Strong intelligence of relevant institutional donor priorities and strategies;
- Demonstrated ability to design clear and coherent programme interventions (including Theory of Change, and log frame development)
- Demonstrated understanding of how to write engaging and convincing technical proposals and reports;
- Strong understanding of civil society and capacity development approaches.

Experience

- At least five years' experience in programme design and institutional fundraising, preferably within the human rights and peacebuilding sector;
- Strong track record of securing funding from both existing and new institutional donors;
- Demonstrated experience in forging new relationships with donors through cold approaches;
- Experience in writing complex and detailed institutional funding proposals and reports tailored to the language of donors including the European Union, FCDO, NORAD, GIZ and the U.S Bureau for Democracy, Rights and Labor;

- Experience securing funding from philanthropic trusts & foundations.
- Experience in establishing multi-partner and multi-country consortia;
- Experience working in insecure and highly sensitive environments, ideally in one or more of the countries in which Cord currently works, would be a distinct advantage;
- Experience working with US and European donors would be a distinct advantage.
