

Why this position is important to us

The role of Product Manager at Stewardship is crucial for our mission of activating generosity. Our Product Manager plays a pivotal role in shaping the product pipeline to meet the needs of customers, key stakeholders, and drive strategic objectives forward. By prioritising the product backlog, conducting user research, utilising data insights, managing stakeholder communication, and optimising processes, each of our Product Managers are key to ensure that Stewardship's products align with customer wants and needs while fulfilling our strategic vision. We're looking for someone to challenge constructively, think analytically, solve problems effectively, communicate clearly and leverage data for decision-making.

Job detail

Overview

Stewardship is on a mission to activate generosity, our products, and the users of those products, are at the heart of that. As the Product Manager at Stewardship, you will join our small but mighty, and growing, Product Team. We are passionate about growth, but not just for numbers, because our growth means Kingdom growth. You will play an important role in shaping our pipeline to ensure we meet the needs of our customers, key stakeholders and push us forward in our strategic objectives.

Main responsibilities

To include, but not limited to:

- Pipeline Prioritisation: Work closely with the Head of Product, developers and key stakeholders to
 define and prioritise our product backlog and develop clear product roadmaps. Collaborate with crossfunctional teams refine, plan and release new features to further our strategic objectives.
- User Research: Develop and maintain a deep understanding of our customers to inform roadmaps that
 directly address customer wants/needs and fulfils our product strategy. This will involve organising and
 conducting regular qualitative and quantitative user research including, but not exclusive to, regular
 customer interviews and user testing.
- Data gathering and interpretation: Working with our new Data and Insights team, you will use data to
 inform our product pipeline, validate hypotheses and monitor the success of implemented features. This
 will encourage a culture of data-informed decision making and continuous improvement through
 learning.
- Stakeholder communication: Working closely with the Head of Product you will help to manage key
 stakeholders across Stewardship ensuring that we are communicating clearly what we're doing, what
 we're not doing, and why. This will involve the production of helpful reports that clearly communicate
 complex information and updates on progress.
- Process Management: There are a number of tools that you will be responsible for, these tools can
 always be more optimally used. Always asking "how can we do this better?" is important in ensuring we
 get the most out of those tools and work most optimally as a team. Therefore, regularly reviewing
 processes and evaluating results to inform ongoing learning and improvement is important.

We recognise that to be great at your role, there are certain characteristics that are important and others that enable a good fit within our existing team and culture.

- You should demonstrate a willingness to offer your perspective and be able to challenge constructively
 when necessary. You must clearly understand and articulate the risks in a situation, taking a balanced
 view regarding those risks.
- You will possess strong logical and analytical thinking skills, enabling you to approach problems with a structured and methodical mindset. Your ability to dissect complex issues and derive sound conclusions is crucial
- Your role requires exceptional problem-solving abilities, allowing you to tackle challenges effectively by identifying root causes, evaluating options, and implementing innovative solutions.
- Excelling in project management will be hugely beneficial, demonstrating the capacity to organise tasks
 efficiently, set clear priorities, and meet deadlines consistently. Strong prioritization skills are essential
 for successful product delivery.
- Effective communication is key; you should be adept at conveying information clearly, listening actively, and fostering open dialogue. Your ability to articulate ideas concisely and engage with diverse stakeholders is important.
- Attention to detail is paramount in your work; you must exhibit meticulousness in reviewing information, spotting errors, and ensuring accuracy in tasks undertaken.
- Your role involves managing diverse relationships; you should have experience in cultivating partnerships, negotiating contracts, and fostering collaborative engagements with various stakeholders.
- You must showcase a track record of leveraging data and research insights to drive informed decisionmaking and strategic development initiatives. Your ability to translate data into actionable plans is crucial.
- You should possess the capability to translate user feedback and insights into tangible actions that enhance outcomes. Your focus on user-centric solutions and continuous improvement is key for driving positive results.
- You will be a practicing Christian and be able to clearly demonstrate a personal commitment to the
 mission, principles, values and practices contained in our Ethos Statement. You should also be able to
 demonstrate enthusiasm for the Christian purposes of the organisation and a readiness to support and
 contribute to its ethos.

Working for us

Q. What are the usual working hours?

A. Stewardship's normal office hours are 9am to 5pm, Monday to Friday, but you may be required to work flexibly between 8am and 6pm in accordance with the needs of the organisation.

Q. How much Annual Leave do you offer?

A. All full-time employees receive 27 days Annual Leave, and 8 days bank holiday leave.

Q. What are the pension arrangements?

A. Stewardship offers a generous pension contribution; the equivalent of 10% of your gross annual salary into a group personal pension scheme (applicable after 3 months service).

A salary sacrifice scheme for personal contributions is also available.

Q. Is it possible to work from home?

A. Yes, we are happy to offer flexibility for this role but would expect you to be able to work in our London office for a minimum of 2 days each month, or as required by the organisation.

Q. What staff benefits do you offer?

A. Once probation has been passed, there are number of benefits available to staff:
