Role purpose

We stand with autistic children and young people, champion their rights and create opportunities. We see a world where autistic children and young people can be themselves and realise their ambitions. Our Time for Ambition strategy sets out the key changes we want to achieve, in fulfilling this vision.

We started as one school and have become a movement for change. As we drive this shift in purpose, we need to further build the evidence that underpins our strategy development, external affairs activities and national services.

The main purpose of the role is to

- Conduct or commission research projects.
- Publish and disseminate research findings to ensure reach and impact.
- Ensure that the charity uses relevant and up-to-date evidence throughout its work.

Key accountabilities and dimensions

- Identify key research needs and questions to continually improve our activities and impact for autistic children and young people
- Draft briefs and commission and manage independent researchers to deliver projects on time and on budget.
- Develop and maintain relationships with universities, evaluation and research agencies, and freelance consultants; and manage requests from external collaborators.
- Clerk the charity's Research Governance Committee.
- Uphold the principles of ethical research, data protection and equity, diversity and inclusion.
- Develop and support co-produced research with autistic children and young people, as well as parents and carers.
- Publish and disseminate research findings to ensure reach and impact.
- Ensure that new evidence is embedded into our resources, the organisational evidence bank.
- Work in collaboration with colleagues to ensure research is well-coordinated with the



- work of teams such as policy, communications, fundraising and service delivery.
- Provide advice and/or quality assurance for colleagues regarding their interpretation of evidence and reporting to funders.
- Conduct desk research and produce briefing papers or supporting material as required.
- Develop and maintain a high degree of knowledge of current research and developments relevant to the charity's work and disseminate this within the organisation.

Any other duties which may be reasonably required from time to time and which are commensurate with the post.

Additional duties

- Demonstrate a continual commitment to safeguarding and promoting the welfare of children and young people.
- To uphold Ambitious about Autism policies to protect and safeguard pupils in order to secure their health, safety and wellbeing.
- Demonstrate a continual commitment to the promotion of diversity initiatives and the sharing of best practice in line with Ambitious about Autisms Equality, Diversity and Inclusion policy and procedures.
- Ensure the highest degree of confidentiality and data protection of all materials
- Demonstrate the vision and values of Ambitious about Autism in everyday work and practice, upholding the ethos of challenge and support where all pupils/learners can reach their full potential and maximise their engagement in learning.
