Help and Hope for Domestic Abuse Survivors

Rebuilding Lives UK is dedicated to helping survivors and their families of domestic abuse rebuild their homes and their lives. A safe and comforting home is essential for recovery, yet many survivors are left in spaces filled with painful reminders of their trauma—shattered walls, broken fixtures, or unfamiliar accommodations that lack even basic comforts. For many, even the sound of a door knock or footsteps behind them still evokes fear.

We provide practical assistance to ensure survivors have the essential foundations needed to heal and move forward with strength and hope. Through compassion, dignity, and kindness, we create safer homes by delivering security solutions, carrying out repairs, and providing essential furnishings—transforming spaces into places of safety and stability.

Every survivor deserves to feel secure in their own home. That's why we provide personal security alarms equipped with SOS features, direct police connections, and audio recording capabilities. These alarms offer immediate protection, giving survivors a vital lifeline in moments of crisis. We also install reinforced doors, security lighting, and additional safety measures to ensure survivors feel safe where they live.

But security is just the beginning. Many survivors are forced to live in homes that hold painful memories of their abuse—walls with holes punched through them, broken doors, and rooms filled with reminders of trauma. We work with trusted tradespeople, including skilled plasterers, decorators, carpenters, electricians, and plumbers, to restore these homes, creating spaces that feel safe and welcoming. We also support families who need to relocate by helping them move into homes that are safe and fully equipped with the necessities they need for a fresh start.

This work is only possible through collaboration. We partner with domestic abuse agencies that refer survivors to us, ensuring that each individual receives support in a trauma-informed way. Companies such as British Gypsum, Weber, Toolstation, Dulux, Wickes, Howdens, Travis Perkins as well as other companies provide essential materials, allowing us to complete vital renovations. By working together with businesses, tradespeople, and volunteers, we are able to transform homes and restore dignity to those who need it most.

Rebuilding Lives UK exists to ensure that no survivor has to live in fear within their own home. Our mission is to create a safe, secure, and healing environment for those who have experienced domestic abuse. Every person we support deserves to rebuild their life with dignity, knowing they are not alone.





Compassion is at the heart of everything we do. We believe in kindness, empathy, and respect, recognising that each survivor's journey is unique. We are committed to delivering our services with integrity and ensuring that every project is completed with care.

Rebuilding Lives UK is deeply committed to safeguarding and promoting the welfare of survivors, volunteers, staff, and everyone involved in our work. We recognise that safeguarding is not just a policy, but a responsibility that must be embedded in everything we do. Our commitment is to ensure that all those we support—and those who support us—feel safe, valued and protected at all times.

Generous trade professionals from Weber and volunteers from *Build A Career* have donated their time and expertise to help renovate homes, while Dulux has provided staff for volunteer days, helping to create warm, welcoming spaces for survivors. Their contributions, along with support from other skilled tradespeople, ensure that every home we restore is a place of safety, dignity, and hope.

Above all, we believe in empowerment. Survivors deserve to feel in control of their futures, and through our work, we help them reclaim their homes, their safety, and their independence.

Our work has been widely recognised through media coverage, raising awareness of the urgent need for safe, stable homes for survivors. We have been featured on ITV, BBC Radio 2, Sky News, Channel 5, and Steph's Packed Lunch, as well as in reports from various news outlets. Comedian Russell Howard has highlighted our mission, and legendary musician Chris de Burgh even performed *Lady in Red* for our founder in recognition of our impact. One of our most recent significant moments came when Lewis Capaldi's song *A Cure for Minds Unwell* featured Naima's story, further amplifying our message and reaching audiences worldwide. The public has rallied behind our cause, and this growing support enables us to continue making a difference in the lives of survivors.

Welcome from the Founder and CEO

My name is Naima Ben-Moussa, and I founded Rebuilding Lives UK because I know firsthand the devastation that domestic abuse, sexual violence, and childhood trauma can cause. I know what it's like to live in fear, to feel unsafe in your own home, and to carry the weight of trauma. From witnessing my mother suffer at the hands of abusers to surviving my own experiences I've seen the impact of domestic abuse, not just in my own life but in the lives of so many others. I also know how powerful it is to take back control, to turn a place filled with painful memories into a home where healing can begin. That's why this charity exists—to make sure no survivor has to face that journey alone.





Rebuilding Lives UK began in 2021 after I was called to a home where a survivor and her young children had endured a terrifying 10-hour assault. Even her child had been forced to call the police. When I arrived to organise some plastering work, I could feel the trauma in the house. Wanting to do more, I set up a JustGiving page to raise funds for materials. The response was incredible—it reached people worldwide and was picked up by major news outlets.

Soon after, I was invited onto BBC Radio 2's *Jeremy Vine Show* to speak about the survivor's experience, as well as my own childhood abuse and rape. It was an overwhelming and emotional moment, but I knew I had to ask the nation for help. The response was extraordinary people came together to support survivors in ways I never imagined. Jeremy himself generously paid for the plastering on the first project, and tens of thousands of pounds were raised in just one interview.

Off the back of that, Nina Hossain joined us as an ambassador, and her mother even offered to come out on projects to help paint. That first act of kindness proved just how many people care and want to make a difference. What started as one home has now grown into a nationwide movement, helping survivors regain safety, dignity, and hope.

Rebuilding Lives UK was born from my own experience of abuse. I know what it means to feel trapped, alone, and without hope. I also know the power of having someone believe in you. That's why I started this charity—to be that helping hand for others.

I've seen the fear in a mother's eyes as she wonders how she will keep her children safe. I've walked into homes destroyed by violence, where every broken door and shattered window tells a story of pain. But I've also seen the incredible strength of survivors. I've witnessed the transformation that happens when they step into a secure home, knowing they are safe at last.

We need trustees who share this passion—who understand that lived experience matters, that rebuilding homes means rebuilding lives. This work isn't easy, but it is vital. Survivors deserve more than just escape; they deserve a future filled with possibility. If you believe in our mission and can commit to this role, we need you. Together, we can continue to bring help, hope, and safety to those who need it most.

About the Safeguarding Trustee Role

Role Overview

The Safeguarding Trustee ensures Rebuilding Lives UK meets all safeguarding obligations and promotes a culture of safeguarding at every level. They provide expert oversight, policy guidance, and ensure best practices are embedded across the organisation. The Safeguarding Trustee works closely with senior leadership to ensure the organisation remains compliant with safeguarding regulations. Trustees are expected to be **actively involved** in the charity's work, providing hands-on support where appropriate.





Key Responsibilities

- Ensure robust safeguarding policies are in place, regularly reviewed, and adhered to.
- Provide safeguarding advice to the board and senior leadership.
- Ensure all trustees and staff receive **appropriate safeguarding training**.
- Oversee risk management relating to safeguarding, ensuring all cases are handled correctly.
- Promote a safeguarding-first approach across the charity's activities.
- Ensure compliance with relevant safeguarding legislation and guidance.
- Act as the board's safeguarding lead, providing regular updates and reports.
- Trustees share collective responsibility for the charity's governance, ensuring the charity's mission is achieved and its operations are effective. Trustees support the CEO by contributing to strategic planning, offering expertise, and working together to provide the necessary oversight and direction for the charity's growth and success.

Who We Are Looking For

Essential Skills & Experience:

- Professional experience in safeguarding children or adults.
- Strong communication skills and the ability to advise on safeguarding matters.
- Awareness of safeguarding regulations in the charity sector.
- Ability to ensure safeguarding remains a board-level priority.

What You'll Gain from This Role

Becoming a trustee with Rebuilding Lives UK is more than just a governance role—it's an opportunity to be part of a team dedicated to creating real, lasting change. As a trustee, you will:

- Play a vital role in supporting survivors and helping them rebuild their lives.
- Be part of a passionate and driven team working towards a shared mission.

- Have access to training and development opportunities to strengthen your expertise.

Mandatory Training Requirement

The Safeguarding Trustee must complete **trustee governance and safeguarding training within the first three months** of appointment. Additional training will follow as needed.





Terms of Appointment

Trustees serve an initial one-year term, with the option for renewal up to a maximum of three years.

Voluntary Role

All voluntary roles are subject to satisfactory references and an enhanced DBS check.

This is an unpaid position; however, reasonable expenses will be reimbursed.

Time Commitment:

- 8 hours per month, including:
 - o Monthly board meetings (held via Zoom).
 - o Active involvement in governance and decision-making processes.
 - o Annual half-day strategy session to contribute to the charity's direction.
 - o Engagement in charity activities beyond board meetings, as appropriate.
