## The role

The Individual Giving team is responsible for driving growth and income sustainability across Individual Giving (one-off donations, Regular Giving, Lottery) In Memory Giving, Legacy Giving and Major Giving. This is an exciting role and it will suit somebody who enjoys working across our different fundraising products, with particular focus on one-off donations, Regular Giving and In Memory Giving. The role will focus on the acquisition and stewardship of donors, maintaining a fantastic donor journey for longer term engagement. The role holder will need to own and manage their workstreams, drawing on the expertise of other in-house teams from Marketing to Finance.



The need for accuracy in data and administrative work requires the role holder to have a keen eye for detail and a respect for processes and regulations.

## What we offer

- Flexi-time – we are flexible about start and finish times, and flexible about your location.

### Key responsibilities

- Develop and deliver key appeals, multi-channel campaigns and engagement activity for the acquisition of new supporters and the retention of warm supporters, liaising with colleagues across the organisation and providing project management. Work with the Individual Giving Manager to ensure targets are met.
- Lead the In-Memory and Celebration Giving programme. Our new In-Memory and Celebration strategy is currently being created and there is an exciting opportunity for the individual in this role to help shape it.
- Deliver targeted stewardship programs in IG, that will drive emotional engagement and future support. This will include leading on the build of our retention programs for one-off, regular givers and in-memory supporters. You will work within a test and learn environment allowing you to try new ideas to improve the journey for our supporters.
- Deliver one-to-one supporter stewardship as needed via emails, letters and phone calls, supported by the Fundraising Support Officer.
- Develop powerful and compelling stories and content that will resonate and inspire our supporters, driving their emotional connection to Kidney Care UK, working alongside colleagues in our Marketing Team.
- Use third-party fundraising platforms (i.e Much Loved, and Enthuse) to support fundraising activities, including implementing bespoke campaign pages.
- Support the Individual Giving Manager with new fundraising initiatives.

- Work with the Fundraising Data Officer to capture and accurately record Individual Giving and In Memory supporter and donation data using our CRM system, Beacon.
- Work with the Fundraising Data Officer to deliver reporting for activities, appeals etc, to understand and implement improvements for effectiveness and performance in future work.
- Optimise efficiency and effectiveness in our processes working with the rest of the team.
- Ensure that all activity complies with current fundraising regulations.

Your main relationships will be with the Fundraising, Marcomms, and Finance teams, as well as donors and supporters.

## General and organisational responsibilities
