OUR MISSION

TRAIN exists to improve the life opportunities of children and young people in Didcot and surrounding areas, especially those who are in need, disadvantaged or vulnerable, by empowering them to make informed decisions, attain stability, and become integrated members of society.

We empower young people to believe in their self-worth, to make good life choices, to accept and value their right to healthy and safe relationships ... and we watch their relationships with family, school and the wider community improve.

OUR WORK

We deliver front-line youth work services across three core pillars:

Place-based, Open Access Provision:

TRAIN runs open-access youth clubs, drop-ins and holiday programmes in South Oxfordshire, offering activities and a safe space with support from dedicated youth workers.


Detached and Outreach:

TRAIN's youth workers engage young people on the streets and in parks, building relationships, providing positive influence, and connecting them to other services.

Targeted Mentoring:

TRAIN provides one-to-one and group mentoring, including specific support groups like our brilliant Shout! group for young LGBTQ+ people, ensuring tailored guidance for young people referred by schools and partners.





CHAIR OF TRUSTEES THE KEY BITS!

As TRAIN's Chair, you'll lead our Board of Trustees, and oversee the work of our CEO ensuring we deliver brilliant outcomes for the young people we support every day!

Your tasks include:

Lead our Board of Trustees meetings
Support our CEO and staff team
Shout about our work, and act as our biggest advocate
Help make sure our Board fulfils its responsibilities and requirements

You are:

An inclusive and strategic leader, who can bring a Board of Trustees with different specialisms together around a clear future plan. You're passionate about your local community, and are keen to help young people in South Oxfordshire thrive.

Time commitment:

We estimate around 10 to 20 hours per month. There will be quarterly board meetings, which are usually on a Tuesday evening. Our CEO undertakes the day to day management of the organisation, but will need some focused support time from you with the bigger picture items.

A typical month might include:

- Preparing for and chairing a Trustee Board meeting (3 to 4 hours)
- Chairing a one-to-one meeting with our CEO (1 to 2 hours)
- Joining TRAIN's sub-committee meetings as required (1 to 2 hours)
- Attending stakeholder and fundraising events (2 to 3 hours)
- Advising and supporting TRAIN's CEO (3 to 4 hours)

CHAIR OF TRUSTEES DETAILED ROLE DESCRIPTION

Alongside fulfilling the role of a Trustee, the Chair leads our Board of Trustees, and manages the Chief Executive Officer (CEO).

The Chair leads in an inclusive way, supporting the board to work together well, and providing support and challenge to the CEO. The Chair also acts as an ambassador for the charity, supporting the CEO with stakeholder engagement, and at key events.

- Provides strategic leadership to the charity and the Board, ensuring that TRAIN achieves its mission.
- Works in partnership with the Chief Executive and team of staff and volunteers to achieve our mission.
- Leads the board in ensuring it fulfils its responsibilities for the governance of the organisation.
- Supports a strong, positive relationship between the board and TRAIN's staff and volunteers.
- Plans and chairs the board meetings, with others as appropriate.
- Acts as a spokesperson and figurehead for TRAIN.

In addition to the above, the Chair will have the responsibilities and qualities of all trustees:

- Support and provide advice on TRAIN's purpose, vision, goals and activities.
- Approve operational strategies and policies, and monitor and evaluate their implementation.
- Oversee and approve TRAIN's financial plans and budgets, monitoring and evaluating progress.
- Ensure the effective and efficient administration of the organisation.
- Ensure that key risks are being identified, monitored and controlled effectively.
- Attend Board meetings, adequately prepared to contribute to discussions.
- Use independent judgment, acting legally and in good faith to promote and protect TRAIN's interests, to the exclusion of their own personal and/or any third party interests.
- Contribute to the broader promotion of TRAIN's objects, aims and reputation by applying your skills, expertise, knowledge and contacts.

CHAIR OF TRUSTEES DETAILED PERSON DESCRIPTION

- Experience of being a trustee.
- Demonstrable interest in, or experience with organisations that support young people.
- A keen sense of strategic purpose and planning.
- A positive, inclusive leadership style, with the ability to inspire and support everyone to participate on an equal footing.
- The ability to listen and engage effectively. You are comfortable with challenge and debate and are able to encourage that in others whilst fostering a collaborative board environment.
- Advocate be able and willing to champion our work through personal networks, social media, and other channels.
- A strong personal commitment to equity, diversity and inclusion.
- Able to be responsive to the needs of the organisation's staff team, and particularly support and advise the CEO as required.
