- Acting as stewards of the charity's assets, safeguarding and responsibly managing both tangible and intangible resources.
- Upholding the highest standards of governance throughout the organisation.

The trustee board meets quarterly (January, April, July and October). Meetings are usually after work hours, often remotely. Plus one strategy day/board development day per year.

This is a voluntary role, but reasonable expenses incurred during your trusteeship are reimbursed by the charity.
