About Quartet

Local giving to meet local need



Quartet Community Foundation is the community foundation for the West of England covering Bath & North East Somerset, Bristol, North Somerset and South Gloucestershire. Our donors, supporters and the charitable organisations we work with have strong roots in the region care deeply about the issues facing people living here. Our aim is to support communities across our region and aim to support those at most disadvantage by funding the VCSE sector (charities and CICs) to do their expert work. We are part of a national network of 47 Community Foundations across the UK matching people who want to give money locally with organisations and charities working to help local communities on the ground. Our main office is in central Bristol at Royal Oak House, and we have a satellite office in central Bath.

Quartet is here to inspire local people and businesses to give locally. We provide expert philanthropy advice to our generous donors and work closely with them to channel their giving to charitable causes that they feel passionate about. We do this by awarding approximately £5 million in grants each year to a wide range of local charities and community groups addressing pressing social needs.

This year marks our 40th anniversary. Over the last four decades we have awarded over £80 million through 27,500 grants to local charitable organisations and advised over 350 fund holders.

Our Strategy

Over the next three years, we aim to inspire increased philanthropic giving, enabling us to respond to greater need in the communities across our region. We will use this funding to increase grants to the voluntary and community sector to reach and have impact on the most disadvantaged areas in the West of England. Our goals are to:

- ❖ **Grow our endowment to £100 million, significantly expanding our impact across local communities.**
By 2029 we will have increased our endowment by £30 million, through trusted relationships with existing donors and reached an additional 20% first time donors, leading grant giving in the West of England.
- ❖ **Diversify and strengthen our donor base, increasing philanthropic giving so we can distribute £6.5 million annually by 2029 in grants throughout our region.**
By 2029 we will have Inspired place based giving through a broader donor base, focusing on areas of unmet need, including rural needs, disadvantage and embedding ourselves in North East Somerset, South Gloucestershire and North Somerset.
- ❖ **Forge high impact partnerships to channel resources into the sector and strengthen sector resilience.**
By 2029 we will have added value to relevant and innovative local partnership opportunities, funding stronger communities in our region.
- ❖ **Embed a culture of continuous improvement, inclusion and learning at every level of our work.**
By 2029 we will have listened to the sector and our donors, giving responsibly, inclusively and flexibly through an expert philanthropy service and a trusted, accessible grant giving service. Our decisions continue to be founded on credible research and evidence.

The role of a Trustee

Main responsibilities and commitments



You will be supported to understand and engage with all these elements:

- ❖ To be actively engaged in setting the strategic direction and policy of Quartet.
- ❖ To contribute to the performance management of the strategic plan and related targets.
- ❖ To live and reflect our values when representing Quartet.
- ❖ To help set and agree a balanced financial budget and support the Chief Executive and staff in achieving it.
- ❖ To be an ambassador and advocate for the work of Quartet in the wider community.
- ❖ To participate in grant-making panels as a representative of Quartet, as required.
- ❖ To visit at least one funded project per year.
- ❖ To attend quarterly board meetings, the AGM and the meetings of one sub-committee (this is eight meetings in total)
- ❖ To ensure that Quartet complies with its Memorandum and Articles of Association, charity law, company law and any other relevant legislation or regulations.
- ❖ To attend relevant external events across the region , our annual events and be a spokesperson for Quartet.

What the role of a trustee involves

As a Trustee, you will work with other members of the Board to form an effective, accountable governing body which provides **leadership and support** for the dedicated staff team delivering Quartet's strategic plan.

Trustees are expected to attend four board meetings a year (each of which normally takes place during normal working hours and lasts approximately 2.5 hours), and Trustees are asked to join one of our four sub-committees below which report to the board, each of which normally meets three or four times per year:

- ❖ Finance and Investment
- ❖ Governance
- ❖ Philanthropy, Marketing and Growth
- ❖ Programmes

As ultimate responsibility and authority for a charity lies collectively with its trustee board, you will need to understand some key elements of charity law and governance – so we'll give you induction training and help you to stay up to date.

Appointments are currently for three years initially, with an option of one further term of three years. This is a voluntary role, Reasonable expenses can be claimed by Trustees, such as travel and parking.

Skills and experience required

Trustees come from all walks of life, and we make sure the whole organisation represents the diverse communities of the West of England. So, if you have never been a charity trustee or sat on a board before, please do still consider applying or getting in touch to discuss the role. All joining Trustees will have the opportunity to shadow a more experienced member of the board, and will be supported by the board and staff team via induction, training and support.

Quartet Community Foundation is a registered charity and a company limited by guarantee, so Trustees are the Directors with the legal responsibility to ensure the organisation is well run and fulfils its public benefit mission. Trustees are expected to set and then commit to the vision, mission and values of Quartet Community Foundation, including an understanding of and commitment to equal opportunities.

Shortlisting for this role will also assess suitability of skills and experience based on the following criteria:

- ❖ **Essential:** Commitment to Quartet's mission, strategy and values, with the judgement, integrity and collaborative approach needed to fulfil charity trustee responsibilities and contribute to effective strategic governance.
- ❖ **Desirable:** Experience or insight relevant to Quartet's work and strategy — such as community engagement and social welfare, grant-making, philanthropy, wealth advice, finance and accountancy, law, property, charity governance or the public or voluntary sectors — alongside an understanding of the needs and diversity of Bath & North East Somerset, Bristol, North Somerset and South Gloucestershire.

Accessibility, EDI and fair recruitment

Quartet is committed to improving equity, diversity and inclusion in all aspects of our work. We want to reflect the diversity of the people who live in the West of England area. This includes those who govern and deliver our work, the donors to our fund, and those who are awarded grants.

As a part of our 2026–29 strategy we are actively seeking to increase diversity on our board (see previous slide). We recruit by merit on the basis of fair and open competition. As a Disability Confident Committed organisation, we will make reasonable adjustments to ensure access needs are met during the application and interview process, and throughout the course of their tenure, while also ensuring that such adjustments will not influence our decision-making. - People of non-Christian faiths.

- ❖ Candidates shortlisted for interview will be invited to attend an interview on Thursday 18th September or Monday 21st September between 9am-5pm, in central Bristol (these dates are subject to change and will be communicated to shortlisted candidates in advance). Interviews will be held with a small, friendly panel of Trustees and the CEO, and will last less than one hour.
- ❖ All applications will be responded to in advance of interviews being held.
- ❖ All appointments will be subject to pre-appointment checks and a declaration of interest procedure.
