Introduction

The Prison Reform Trust (PRT) was founded in 1981 to inform public debate and improve prison conditions and the treatment of prisoners, amidst concerns about a projected prison population of 48,000 by 1984. Fast forward to today, the prison population in England and Wales is almost 90,000 and is projected to rise to 106,300 by March 2027. We overuse prison for non-violent and persistent crime, and we choose to send people to prison for a long time, and it continues to grow.

Our mission is clear. We are working to create a just, humane and effective prison system by influencing decision-makers opinion formers and the public to 1) reduce the use of prison; 2) Improve conditions for prisoners and, 3) promote equality and human rights in the criminal justice system.

Income in 2023 was £2.06 million. We are an unusual charity in that a very large proportion of our income is derived from trusts and foundations, with whom – in many cases — we have had very long-term relationships. We have recently concluded a strategic development period, as part of which we have committed to diversifying our income. This has led to the appointment of a new Head of Fundraising and Philanthropy (a member of PRT's Senior Management Team) whose role is to oversee all fundraising activity and, particularly, to focus on individual giving, major donors, and corporate relationships. With the promotion of the current Senior Development Manager to the role of Head of Operations, the opportunity to restructure the fundraising team has led to the recruitment of a Trusts and Foundations Officer to work with the Head of Fundraising and Philanthropy to maintain our extraordinarily successful T&F fundraising function. We are also

recruiting for a part-time departmental administrator to support the work of the Head of Fundraising and Philanthropy and the Trusts and Foundations Officer.

You will have some demonstrable experience of successful Trusts and Foundations fundraising, be highly organised and efficient, and be an excellent writer. You will be comfortable networking and engaging with funders in person as well as through written applications. If this sounds like you, you will be joining a reputable organisation with exceptional leadership and extensive networks, and your development as a fundraiser will be well-supported.

Overall aim

- To maximise and grow Prison Reform Trust's income by implementing the fundraising strategy, ensuring Trust and Foundation fundraising targets are met and exceeded and in line with evolving needs.
- With the support of the Head of Fundraising and Philanthropy, to lead on identifying, researching, proposal-writing and engaging Trusts and Foundations in a relational manner.
- To play a full part in the wider fundraising function, supporting and deputising for the Head of Fundraising and Philanthropy as appropriate.

Key responsibilities

Fundraising and Philanthropy

- Research trusts, foundations, and grant funding bodies to identify those where the application criteria match elements of the work of PRT.
- Prepare, write, and submit a portfolio of persuasive grant & trust applications.
- Research and collate information and/or data required to make applications to trusts, foundations and grant funding bodies so to provide them with compelling cases of support.
- Establish and manage long term, effective and profitable relationships with existing and prospective funders by providing excellent donor and supporter care.
- Increase pool of potential funders by using sector knowledge and scoping of the funding landscape to identify alternative funding opportunities.
- Use specialist trust & grants sector knowledge to identify new trust funders and increase opportunities for generating new income.
- Maintain and develop efficient ways of keeping trusts, foundations and grant funding bodies updated on the work of the charity and the difference their support makes, to develop and maintain relationships, to maximise shortand long-term support.
- Provide the Head of Fundraising and Philanthropy with regular updates and monthly progress reports.

• Monitor application deadlines, submissions, acceptances/refusals, income received and ensure all information is updated accurately on the database.

General

- Maintain excellent working relationships with other teams within the organisation especially service delivery, campaigns and finance.
- Assist in developing and maintaining an effective website so donors have a seamless user experience.
- Assist in developing and maintaining an effective CRM system, automating processes where possible.
- Ability to work outside normal office hours/flexibility for events and networking opportunities.
