The fundraising, communications, and engagement directorate at Breast Cancer Now is responsible for communicating, engaging, and fundraising to our key audiences across a range of channels; from people living with or beyond breast cancer and their loved ones, to supporters, corporate partners, policy makers and healthcare professionals. We create and deliver high-quality, engaging information and communications about breast cancer, the impact our work has and ways to engage with Breast Cancer Now. We're led by the voices of people affected by breast cancer and involve them and champion their views and needs across a range of communications and platforms.

We're working hard to build our brand to builds awareness, trust, loyalty, passion, and affinity with people affected by breast cancer and to be here for everyone who needs us.

We're responsible for delivering c£40 million gross income annually through our fundraising. We fundraise through a broad portfolio of fundraising products, partnerships, and relationships, all with the aim of delivering sustainable income and valued relationships for supporters and for Breast Cancer Now for the long term. We work collaboratively across the charity to develop fundraising which shows the impact our supporters have and the change we want to see in breast cancer.

All our work, and our focus it so be here for anyone affected by breast cancer, with support for today and hope for the future.

#### Job purpose

To lead the growth and development of Breast Cancer Now's small and mid-level trust fundraising programmes. The trusts officer will manage an established and varied portfolio of small and mid-level trusts, generating sustainable income through compelling funding proposals and exceptional stewardship.

### Key tasks and duties

- Work alongside the senior trusts and statutory manager and head of trusts and statutory to generate long term, sustainable income from charitable trusts and foundations.
- Manage and cultivate Breast Cancer Now's relationships with small and mid-level trusts (donations up to £40,000), securing support through inspiring funding proposals and careful stewardship.
- Lead the delivery of the small trusts programme, creating compelling biannual mailings to encourage regular support and grow income from this key group of unrestricted donors.
- Ensure excellent account management and stewardship for small and mid-level trusts, including timely gift acknowledgment, impact reporting and *ad hoc* updates about Breast Cancer Now's work.
- Work closely with colleagues in the research, services and influencing directorate to present Breast Cancer Now's work in an engaging and informative way through a mix of post, email, face-to-face and phone communications for example:
  - bespoke funding proposals
  - project impact reports
  - fundraising mailings
  - in-person meetings
  - detailed funding application forms
  - verbal presentations.
- Work with the prospect research and information manager to identify new opportunities to sustainably grow trusts' income and engage new donors.
- Work with the finance and supporter care teams to ensure that trust donations are

accurately coded in accordance with funding agreements and donor expectations.

- Maintain accurate, up to date records on the Unity database (Blackbaud CRM) for all activity, including applications, mailings, updates and income, in adherence with GDPR.
- Develop strong and effective internal relationships with colleagues in all teams, ensuring the work of the philanthropy and special events team is understood and supported.
- Be an ambassador for Breast Cancer Now at meetings and events, knowledgeably and passionately representing the charity and our work.
- Maintain excellent knowledge of grant giving bodies, the charity sector and trends, identifying and capitalising on fundraising opportunities.
- Work outside of normal working hours (Monday-Friday, 9am-5pm) where required, for example representing Breast Cancer Now at evening or weekend events, meetings and conferences throughout the UK.
- Adhere to all Breast Cancer Now's policies and procedures.
- Any other duties within the scope and remit of the role, as agreed with your manager.
